

## **CONSTITUTIONAL AND STATUTORY PROVISIONS INVOLVED**

**STATEMENT OF THE CASE**

1. Petitioner was convicted of the charges of Conspiracy to Defraud the United States 18 U.S.C. 371, Interstate Stalking 18 U.S.C. 2261(a)(1)(2), and suffered a judgement in the Circuit Court of Northern District Tuscaloosa County Alabama on 4-6-2022 / 7-23-2021.

The Court of Criminal Appeals <sup>11th circuit</sup> affirmed the judgement on : 3-21-2024.  
An application of rehearing was not filed.

A copy of the opinion of the appellate court is attached which shows the Appeals case to be No. 22-11159 and the copy of U.S. District Court of Northern District of Alabama Jasper Division case : No.: 6:19-CR-433-LSC is attached also.

#### REASONS FOR GRANTING THE PETITION

(1) The Basis of the petitions for the Writ is that the appellate Court held valid a state of Federal Statute or Incorrectly initially construed a controlling provision of the Alabama or Federal Constitution. The issue is whether the appellate court erred in holding that Errors of Facts, confused the defendant with the other Co-defendants, and made their opinion based on Misguided Information.


(2) The Basis of this petition for the Writ is that the decision affects a class of Constitutional, and State or County officers.
