MEMORANDUM FOR THE UNITED STATES

Petitioner contends (Pet. 5-9) that New York attempted second-degree murder, in violation of New York Public Law § 125.25(1), does not qualify as a “crime of violence” under 18 U.S.C. 924(c)(3) on the theory that the crime can be committed by an act of omission and therefore does not “ha[ve] as an element the use, attempted use, or threatened use of physical force against the person or property of another.” This Court granted certiorari in Delligatti v. United States, No. 23-825 (June 3, 2024), to consider whether that interpretation of Section 924(c)(3) is correct. Accordingly, the petition for a writ of certiorari should

be held pending the Court's resolution of Delligatti, and then disposed of as appropriate in light of the decision in that case.*
