28 U.S. Code § 453 - Oaths of justices and judges

"Each justice or judge of the United States shall take the following oath or affirmation before performing the duties of his office: "I, \_\_\_\_\_, do solemnly swear (or affirm) that I will administer justice without respect to persons, and do equal right to the poor and to the rich, and that I will faithfully and impartially discharge and perform all the duties incumbent upon me as \_\_\_\_\_ under the Constitution and laws of the United States. So help me God."

## **FIDUCIARY DUTY**

Fiduciary duty to the People to care, show loyalty and to be obedient to the law.

## **ALL CRIMES ARE COMMERCIAL**

§ 72.11, "ALL CRIMES ARE COMMERCIAL" and must have "nature and cause" and "be prosecuted in the name of the people of the states, as a 'real party in interest', NOT, 'THE PEOPLE OF THE STATE OF', corporation, the fiction." (Id.) The Court notes that 27 C.F.R.

## **UNITED STATES CONSTITUTION**

Section 1 of the 14th Amendment to the United States Constitution establishes the following rights and guarantees:

### **Citizenship**

All people born or naturalized in the United States are citizens of the United States and the state they reside in.

### **Privileges and immunities**

No state can make or enforce laws that abridge the privileges or immunities of citizens.

### **Due process**

No state can deprive a person of life, liberty, or property without due process of law.

### **Equal protection**

No state can deny any person within its jurisdiction equal protection under the law.

## **THE PREAMBLE**

"We the People of the United States, in Order to form a more perfect Union, establish Justice, insure domestic Tranquility, provide for the common defence, promote the general Welfare, and secure the Blessings of Liberty to ourselves and our Posterity, do ordain and establish this Constitution for the United States of America."

## **TREATY LAW**

### **HAUDENOSAUNEE, OR THE SIX NATIONS/ CAYUGA/SENECA OKLAHOMA**

According to ancestral research the appellant is a descendant of aboriginal tribe/s indigenous to these lands.

"The Treaty of Cananadaigua, 1794, CONFIRMED PEACE between the United States and the Haudenosaunee, or the Six Nations; whom are my distant ancestors according to research. "The Great Law of Peace (Mohawk: *Kayanere'kó:wa*), also known as **Gayanaashagowa**, is the oral constitution of the Iroquois Confederacy... In October 1988, the U.S. Congress passed Concurrent Resolution 331 to recognize the influence of the Iroquois Constitution upon the American Constitution and Bill of Rights." ["H. Con. **Article 1:** His Britannic Majesty acknowledges the said United States, viz., New Hampshire, Massachusetts Bay, Rhode Island and Providence Plantations, Connecticut, New York, New Jersey, Pennsylvania, Maryland, Virginia, North Carolina, South Carolina and Georgia, to be free sovereign and independent states, that he treats with them as such, and for himself, his heirs, and successors, relinquishes all claims to the government, propriety, and territorial rights of the same and every part thereof." 
