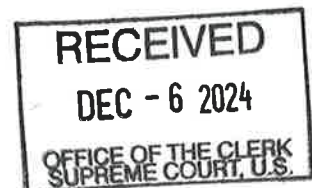

1. Comes Now, Petitioner/ Appellant Daniel Luke Meier files this Petition for Rehearing as support Mr. Meier states the following.

2. Pursuant the letter from the Clerk of this Court dated November 18, 2024. Mr. Meier's original Petition for Rehearing postmarked November 4, 2024 and received November 14, 2024 was returned due to failure to comply with rule 44, which requires a certificate and statement of good faith. This amended submission is being submitted to correct those errors.

3. Mr. Meier filed with this court and served on Allstate a Motion to consolidate Cases Allstate case 23-1904 and Wyndham case 23-1101 on July 28, 2024 because they both were proceeding at the same time in the sixth circuit and both included repeated outrageous violations of law, denial of equal protection rights, denial of due process rights and fraud upon the court under 42 U.S.C. § 1983. This motion was never brought before the court in violation of appellate rules and Mr. Meier's due process rights and does not appear on the court's docket at all. Allstate filed a response to this motion through Mr. Williams who is not a member of the bar of this court and did so in violation of Supreme Court Rules 5 and 9.1. These are intervening circumstances of a substantial or controlling effect.



Additionally, Mr. Williams filed a waiver (which admits he is not a member of the bar of this court) with this court and *never served Mr. Meier with a copy of the waiver* as required by law, and even on the waiver itself, Mr. Meier is not listed as being copied or served which is also a violation of

rules and procedures and Mr. Meier's due process rights. This is consistent with Mr. Williams's unethical and fraudulent behavior in all prior proceedings where he filed frivolous motions to quash a subpoena, which did not even exist, and the judge even granted the baseless motion through fraud upon the court. Since there is no accountability in either of these proceedings at all, there is in fact no proper legal reviews and no system of justice for the people in the Sixth Circuit Court of Appeals and it undermines the entire stability of our nation and the entire rule of law.

CONCLUSION

Based on the foregoing reasons, this Petition for Rehearing should be granted.




