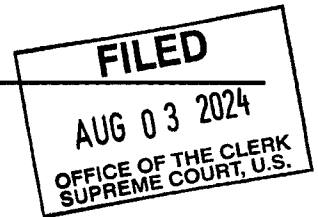

MOTION FOR LEAVE TO PROCEED IN FORMA PAUPERIS


NOW COMES, Petitioner, Derrick Leon Hills, In Propria Persona, and in support of his motion for leave to proceed in forma pauperis states that:

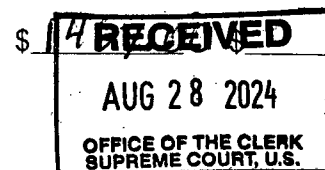
**AFFIDAVIT OR DECLARATION


