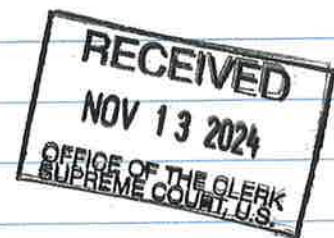

TO THE HONORABLE JUSTICES OF THE
SUPREME COURT OF THE UNITED STATES:

PERSUANT TO RULE 44 OF THE SUPREME COURT
RULES, PETITIONER RESPECTFULLY SUBMITS THIS
PETITION FOR REHEARING IN THE ABOVE
CAPTIONED CASE ON THE FOLLOWING GROUNDS:

GROUNDS FOR REHEARING:

1. Intervening Circumstance OF SUBSTANTIAL
EFFECT:

SINCE THE ORIGINAL DECISION, THERE HAVE
BEEN SUBSTANTIAL INTERVENING LEGAL
DOCUMENTS AFFECTING THE CONTROLLING
PRINCIPLES OF THIS CASE.

SPECIFICALLY, THE IMPROPER JURY INSTRUCTIONS REGARDING 841 SUBSTANTIVE CHARGES AGAINST PHYSICIANS. IN THE SUPREME COURT CASE RUAN V. UNITED STATES. LIKE RUAN, DR. CLEVELAND J. ENMON, M.D. CONTESTED THE OBJECTIVE STANDARD USED ON THE PRONG OF USUAL COURSE OF PROFESSIONAL PRACTICE ON DIRECT APPEAL. THE RULING CLEARLY STATES THAT THE OBJECTIVE STANDARD IS A CIVIL AND NOT CRIMINAL STANDARD, AND THEREFORE, ANY PHYSICIAN WHO HAS BEEN CONVICTED OF 841 SUBSTANTIVE OFFENSES UNDER THIS STANDARD HAS BEEN WRONGFULLY CONVICTED. THE CORRECT AND ONLY STANDARD TO AUTHORIZE A CONVICTION OF A PHYSICIAN REGARDING 841 OFFENSES IS THE SUBJECTIVE STANDARD. THE PETITIONER IS ASKING THE COURT TO CORRECT THIS EGREGIOUS MISCARRIAGE OF JUSTICE.
