COMES NOW, Defendant-Appellant moves for an Order:

Granting leave pursuant to Rule 37 of the Colorado Rules of Criminal Procedure to proceed on appeal in forma pauperis, without payment of filing fees and costs;

Ordering a free transcript in the within case; and

Appointing the Colorado State Public Defender's Office as counsel to represent Defendant-Appellant in this appeal on the following grounds:

Troy Fields was accepted for Public Defender representation on or about March 18<sup>th</sup>, 2017. Initially, the Office of the Public Defender was appointed to represent Mr. Fields, however Mr. Fields elected to proceed pro se. On November 26<sup>th</sup>, 2018, Undersigned counsel was appointed as advisory counsel, and on April 19<sup>th</sup>, 2019, the Court found a conflict and appointed undersigned counsel as Alternate Defense Counsel. Mr. Fields is indigent and without funds with which to pay the filing fees and costs of an appeal; and with which to pay for a transcript of the proceedings and record on appeal; and with which to employ counsel on appeal. Mr. Fields is presently serving a Sentence of Life with the possibility of parole after 40 calendar years.
