STATEMENT OF CASE

My name is Madena Bishop. I have endured a lot since I filed this case on July 20, 2022, case # 2022 L006465 filed at the Circuit Court of Cook County, Illinois Law Division, Calender R Docket, court room 2208, Located at 50 W. Washington St. Chicago, Illinois 60602. I'm seeking justice for the heinous act of "RAPE" brought on me by two Korean of Asian descent , Barry Wenig, M.D. for my bouched sergery and after care neglect, and attempted murder by Grace Zieba DNP, RN while under the care of The University of Illinois Hospital & Health Science System(UIC), located at 1640 S. Taylor St. Chicago, Illinois 60612, and the continuous neglect of justice by three judicial systems in the State of Illinois; The United States District Court Northern District of Illinois, located at 150 S. Dearborn, Chicago Illinois 60604; The Circuit Court of Cook County located at 50 W. Washington St, Chicago, Illinois 60602; The Appellate Court of Appeals, #14, Located at 160 N. Lasalle St, Chicago, Illinois 60601. I'm asking the Supreme Court of the United States located at 1 First Street, N. E. Washington, DC 20543, to right the wrong done to me during this legal process." Equal Justice under the Law". The Circuit Court of Cook County is to provide the citizens of Cook County and the participants in the judicial system an efficient, technological, and transparent court system. I have written three letters to the Office of Executive Inspector General located at 69 W. Washington St. Chicago, Illinois 60602 Suite 3400 complaining about my mistreatment by the employees of the Circuit Court of Cook County located at 50 W. Washington St. Chicago Illinois 60602; The United States District Court Northern District of Illinois is to provide the highest level of service to the court and all people having business before the court. They maintain the public record of court proceedings, provide access to the court and administrative support to the court's judicial officers. They are to earn the public's

trust and confidence by carrying out their mission in a manner that is accurate, efficient, courteous, and easy to understand. I experienced the total opposite. I was allowed to set up a meeting through the Hibbler Program which allows a citizen to get some legal advice and learn how the United States District Court Northern District of Illinois work, Located at 150 S. Dearborn St. Chicago, Illinois 60604. case # 1: 23-cv-13882, I filed my case on or around September 19, 2023, I amended my complaint on or around October 25, 2023, after talking to the lawyer and submitting my amended complaint, I was told by the clerks office that the Hibbler Program was canceled and there was no other assistance available for me, Madena Bishop. on or around October 31, 2023 my case was dismissed with prejudice. I filed a notice of appeal on or around November 21, 2023 .case # 23-3261 with the United States Court of Appeals For the Seventh Circuit, my case was dismissed on or May 15, 2024, because of lack of payment I filed for leave to proceed on appeal in forma pauperis it was denied on or around December 13, 2023. I was able to show I was indigent at that time in my life. The Appellate Courts of Appeal was created to relieve the Supreme Court overwhelming case loads. My experience with the Appellate Court located at 160 N. LaSalle St. Chicago, Illinois 60601. I filed my case on or around December 8, 2023, case # 1-23-2312. I have had to file two extensions in order to complete my briefs according to the truth, I'm still waiting on the Appellate Court to allow the second extension, while I await the answer to the motion to dismiss Barry Wenig M.D. filed by Attorney Jillian Book and my motion of objection to the motion to dismiss and my motion of submission of the police flash drive interview and the Portable drive from my hospital stay at the University of Illinois Health & Science System (UIC) located at 1640 S. Taylor St. Chicago, Illinois 60612. My case was dismissed on or around June 26, 2024. I filed an amended complaint for Barry Wenig M.D. it never reflected that filing trusting in the Appellate Courts Judgement on the

documents, I was simply tricked by the Appellate court into believing that my entire case Grace Zieba ET, Al, including Barry Wenig M.D. was in the court of Appeals, thinking this I ignored the three orders written by Jillian Book authorized by the Honorable Judge Anthony C. Swanagan and the Honorable Michael F. Otto and accused the Judges and the Attorney of illegally holding hearing and sent letters out to The Office of the Executive Inspector General Located at 69 W. Washington St. Chicago, Illinois 60602 Suite 3400 and to Iris Martinez Clerk of the Circuit Court of Cook County located at 50 W. Washington St. Chicago Illinois 60602, Suite 1001. I have prepared this statement for a call to action for my God given rights guaranteed by the constitution Rule of Law, Equal Access to Justice Act (EAJA), regardless of race, religion, economic status. I'm limited to equal access of justice because of the State of Illinois and Government interference. Those who are deprived of justice are deprived of hope, those who are deprived of equality are deprived of hope. Therefore I'm asking The Supreme Court of The United States located at 1 first Street, N. E. Washington, DC 20543, to fulfill the promise of the United States Constitution to help me (Madena Bishop) get "Equal Justice under the law"(EAJA). With your help we can give hope and inspiration to those women who are currently facing similar situations while also creating awareness to prevent this from happening in the future.

ARGUMENTS

I (Madena Bishop) Plaintiff, filed my case in the Circuit Courts of Cook County, Illinois, Law Division located at the Richard J. Daley Center 50 W. Washington St. Chicago, Illinois 60601, on July 20, 2022. My assigned case number is 2022 L006465, my case is on Calendar R Docket, Court room 2208. My case was not process according to the Illinois Supreme Courts Rules (ISCR). I paid for a jury trial of twelve to decide my case. My case in its entirety was decided by three judges, The Honorable Judge Daniel A. Trevino, The Honorable Anthony C. Swanagan and The Honorable Judge Michael F. Otto who currently sits on the bench of calendar R, Docket, court room 2208. By way of zoom The Honorable Daniel A. Trevino on or around October 12, 2022, gave me (Madena Bishop) instruction to complete my case management statement by January 11, 2023. The Honorable Judge Daniel A. Trevino introduced me to Attorney Jennie E. Miskell at this zoom meeting as the Attorney that would be representing The University of Illinois Health System, Et, Al, (UIC)Defendants. I have a witness to this account her name is Trina Johnson relationship (sister). Attorney Jennie E. Miskell is an associate for Anderson, Rasor & Partners, LLP, located at 150 S. Wacker Drive Chicago, Illinois 60606 Suite 350.

"She never filed an appearance, an answer nor did she file a motion to dismiss".

My next zoom meeting with the Honorable Judge Daniel A. Trevino and Attorney Jennie E. Miskell was January 11, 2023, The Honorable Judge Daniel A. Trevino did not address the case management statement. She and the Judge instructed me to agree to an in- person hearing on March 28, 2023. I filed a motion to Substitute Service on February 27, 2023, because I had not yet served the Defendants. On or around March 17, 2023, I received a motion to dismiss from Attorney Jillian F. Book because The Board of Trustees was being sued by the wrong name. I was ordered by the Honorable Judge Daniel A. Trevino to amend my complaint in 21 days. On or around March 15, 2023, The Attorney for the Defendant Anderson, Rasor & Partners, LLP filed an appearance on behalf of The Board of Trustees of The University of Illinois. On or around March 31, 2023, The Honorable Judge Daniel A. Trevino and Attorney Jennie E. Miskel offered me a proposal in the form of a Court order I agreed and sent my handwritten agreement by email. I received by email from Attorney Jennie E. Miskel a Court Order not stamped or signed off by the Honorable Judge Daniel A. Trevino. I have included motion filed on or around April 25, 2023, and May 8, 2023, and for June 6, 2023, court appearance in which I did not get a written court order for each issue from the Honorable Judge Anthony C. Swanagan. The Court order written by Attorney Jillian F. Book

representing The Board of Trustees of the University of Illinois, was stamped and not signed by the Honorable Judge Anthony C. Swanagan. I have included my amended complaint and the response from Attorney Jullian F. Book of Anderson, Rasor & Partners, LLP. On or around June 6, 2023, I was given until July 18, 2023, to amend my complaint. Court Order written by Attorney Jillian F. Book on or around July 18, 2023, stamped but not signed by the Honorable Judge Anthony C. Swanagan. I filed a motion to amend my complaint on or around July 26, 2023, to buy more time my motion was denied. I filed a complaint concerning my documents not getting stamped "for example" my motion to reconsider to quash the subpoena for the Midas Risk Management Report that puts Grace Zieba in my room. Motion filed on or around July 19, 2023. Motion written by Attorney Jillian F. Book not stamped by courts, No Court date entered, but signed by The Honorable Judge Anthony C. Swanagan. I filed a motion for depositions and discovery on or around July 31, 2023, and August 10, 2023, pursuant to ISCR rule 213 all ignored by The Honorable Judge Anthony C. Swanagan and Attorney Jillian F. Book. I filed another Motion on August 22, 2023, Pursuant to ISC rule 213 The Honorable Judge Anthony C. Swanagan finally wrote a court order but not giving Attorney Jillian F. Book instruction to allow the interrogatories, The Court Order was written on or around August 23,2023. giving Attorney Jillian F. Book filling

instructions and me Madena Bishop instruction to file my Third amended complaint. Court Order stamped for September 22, 2023, but not signed by the Honorable Judge Anthony C. Swanagan. Court Order Stamped but not signed by the Honorable Judge Anthony C. Swanagan for my rape kit report. I filed a notice of removal Pursuant to 28 U.S.C. 1441(c)(1). Court Order written by Attorney Jillian F. Book, on or around November 7, 2023, was stamped by the courts and not signed by The Honorable Judge Anthony Swanagan. December 11, 2023, Court Order Written by Attorney Jillian F. Book, stamped and not signed by the Honorable Judge Anthony Swanagan. I filed with the Appellate courts of appeal on or around December 6, 2023, located at 160 N. LaSalle Chicago Illinois 60601. I was informed that my entire case had been transferred to the Appellate courts of appeals. I sent an email to all parties involve finding out why the Honorable Judge Anthony C. Swanagan was still allowing Attorney Jillian F. Book to write Court orders, no response. The Judge made a remark in court that prompted me to amend my appeal on or around December 19, 2023. January 11, 2024, Court order written by Attorney Jillian F. Book, not signed by the Honorable Judge Anthony C. Swanagan but stamped. March 19, 2024, Court order written by Attorney Jillian F. Book stamped but not signed by the Honorable Michael F. Otto. Affidavit of Grace Zieba, four pages of proceeding dated for October 3, 2023,

email to me by Attorney Jillian F. Book, August 2, 2023 agreed order, Court order not signed or stamped by the courts emailed to me by Attorney Jillian F. Book. August 14, 2023, Court order signed and stamped by the Honorable Judge Anthony Swanagan saying my motion to abridge the deadline to answer interrogatories DENIED. September 16, 2023, letter for Request of discovery by hand delivery, email and by mail. March 28, 2023, Court order to Defendants motion to dismiss not signed, not dated, not stamped by the Courts or the Honorable Judge Anthony C. Swanagan. emailed to me by Attorney Jillian F. Book. November 3, 2023, Plaintiff motion Pursuant to Rule 901. (a)(8)(9)(10). Transport tracking documents submitted by Defendants (UIC). Documents submitted by (UIC) December 6, 2023, Plaintiff motion to reconsider dismissal of Barry Wenig M.D. Appellant's General number 1-23-2312. The Appellate court simply tricked me into thinking my entire case had been moved to the courts of appeal. Motion filed with the Appellate Court of Appeal showing Complaint letter sent to Iris Y. Martinez and The Office of Executive Inspector General with attachments. Office of Executive Inspector General Response Letter Complaint #24-01137. I amended my Appeal on December 19, 2023, and the Appellate Court of Appeal never changed the appearance of the Defendant to reflect Appellee/Defendant Barry Wenig, M.D. nor did the Circuit Courts of Cook County, Illinois, Law Division send

my common law records or the court proceeding in a timely manner. I had to file for two extensions to submit my briefs which never happened. Attorney Jillian Book filed an appearance on or around March 5, 2024. citing Rule 361(H).

Attorney Jillian F. Book has filed a motion to dismiss for lack of Jurisdiction and filing out of order filed on May 23, 2024. On June 5, 2024 I(Madena Bishop filed a motion with the Appellate court of Appeals Pursuant to ISCR 304(a) Appeals from final Judgement. My Appeal from the Appellate Courts located at 160 N. Lasalle St. Chicago, Illinois 60601. Case # 1-23-2312 was dismissed for lack of jurisdiction and not filing for the supplement of documents on or around June 26, 2024. Attorney Jillian F. Book emailed and sent by Hard copy on or around December 22, 2023, a notice of filing, a notice of motion, a filed appearance on behalf of Detective Micheal Murphy and a Court Order not signed or stamped by the courts or signed by the Honorable Judge Anthony C. Swanagan for an extension to file an answer for Defendant Detective Michael Murphy. I filed a motion December 8, 2023, Docketed statement, February 9, 2024, Appellant's Brief schedule, Appellate court order March 21, 2024. Appellate Court order March 5, 2024. Appellate Court order March 5, 2024. Court ordered by March 19, 2024, My Appellant list. Motion for Appellee/Defendants to supplement. Missed filing from Attorney Jillian F. Book office. Four Affidavit of Drone Sighting, Court Order for Waiver of Court Fees

signed by Honorable Judge Kathy Flanagan. I filed my case with the United States District Court Northern District of Illinois on or around September 19, 2023, Complaint Case# 1:23-cv-13882. Amended Complaint filed October 25, 2023. Request to prepare transcript December 19, 2023. I was allowed to speak to an Attorney from the Hibler program only once. The Attorney focus was to get me to take Governor J. B. Pritzker name off the complaint and file John Doe. The Hibler program was canceled. I was told that no other programs existed to assist me. My case was dismissed on or around November 21, 2023. I file an appeal with the United States District Court Northern District of Illinois located at 219 S. Dearborn St. Chicago, Illinois 60604. Appeal case# 23-3261. I still wasn't allowed to get the legal assistance available to me. My case was dismissed on May 15, 2024.

CONCLUSION

I'm asking the Supreme Courts of the United States to find the defendants in default and find in favor of me for the miss handling of case# 2220 L006465 from the beginning which should supersede any ladder orders. I paid for a jury of 12 of my peers that never happened. I filed a case management statement instructed by the Honorable Judge Daniel A. Trevino he also introduced me to associate Attorney Jennie E. Miskell who works for Anderson, Rasor & Partners, LLP located at 150 S. Wacker Dr. suite 350 Chicago, Illinois, 60606. Attorney Jennie E. Miskell didn't file an appearance nor an answer she just appeared those guidelines were violated according to the Illinois Supreme court rules. Jillian F. Book, the Attorney for the Defendants is no longer on the case, nor does she work for Anderson, Rasor & Partners, LLP. Jillian F. Book miscarried justice by circumventing the Illinois Supreme Courts Rules Guidelines (ISCR). Jillian F. Book debacle of this case shows in her filings and the Affidavit written by Defendant Grace Zieba, DNP, RN. stating she wasn't at the hospital on the date of my rape by two Korean of Asian ethnicities. Associate Christopher C. Heery of Anderson, Rasor & Partners, LLP. has now been given this case and the courts has not yet reported the criminal

expect of this case to the States Attorney office. I spoke with Deputy Director Brennan Baldwin office located at 2650 S. California, Ave. Lobby Chicago, Illinois 60608 (773) 674-2951. and he said the case must come through the court system so it can be assigned to the States Attorney office that never happened. last but not least the University of Chicago Police Department(UICP) falsified police report orchestrated by Detective Michael Murphy and the Flash drive of the interview of 6 total photo arrays of Korean of Asia ethnicity and 1 of which was a female lineup administered by detective Martinez and the Hospital portable flash drive and the medical records I never got in order to submit my affidavit and health professional written report pursuant to 735 ILCS 5/2-622 concerning Barry Wenig, M.D.

CONCLUSION

The petition for a writ of certiorari should be granted.
