ERROR IN WAITING TO MAIL APPEAL. THUS, VIOLATED PETITIONER'S

The following order was passed:

SAMUEL ROSCOE ARNOLD, JR. v. THE STATE.

After an April 2022 jury trial, appellant was convicted of murder and other crimes. He was sentenced in June 2022, and his counsel timely filed a motion for new trial that remains pending below. Regardless, appellant filed the underlying notice of appeal pro se on October 11, 2023, seeking to appeal the trial court's August 16, 2023 order dismissing a statutory speedy trial demand he had filed in June 2021.

Assuming, without deciding, that appellant was entitled to directly appeal the order dismissing his statutory speedy trial demand even after the conclusion of his criminal trial, see *Hubbard v. State*, 254 Ga. 694, 695-696 (333 SE2d 827) (1985) ("criminal defendant is not required to follow the interlocutory procedures of OCGA § 5-6-34 (b) *when appealing, prior to the conclusion of a trial on the merits*, from the denial of a plea in bar based on OCGA § 17-7-170") (emphasis supplied), his October 11, 2023 notice of appeal was not filed within 30 days of the August 16, 2023 order and, therefore, this appeal would be untimely. See OCGA § 5-6-38 (a). And, assuming that, under the circumstances of this case, appellant is not entitled to a separate direct appeal from the dismissal of his statutory speedy trial demand, then his notice of appeal is premature because there has been no ruling on his motion for new

trial. See *Pounds v. State*, 309 Ga. 376, 385 (846 SE2d 48) (2020) (dismissing a notice of appeal that was filed while the motion for new trial remained pending). Either way, this appeal must be and hereby is dismissed.
