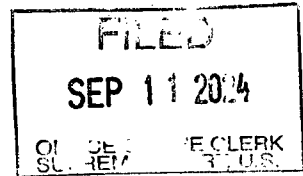

STATEMENT OF THE CASE

1. Defendants includes Premier of P.R. China, military general (O-10), Ministry of China Police and secret police, they are sued for murder and robbing.

2. The Third Court of Appeals confirm FBI investigation result and facts by not denying on OPINION filed at July 3, 2024, confirm my claim for damage compensation caused by Defendants' murder and robbing(BRIEF to US Court of Appeal for the Third Circuit, Mar. 29, 2024, Page 2, last paragraph) by not denying, however supporting lower court judgement to dismiss the lawsuit for Complaint clarity. Decision conflict between the two courts.

3. It is believed that U.S. Department of Justice Office of the Inspector General will file against some defendants of this case in a criminal lawsuit, which will bring more exhibitions and evidence to response to District Court's judgement.

4. The Inspector General Office is investigating the lawsuit process of US District Court for the Western District of Pennsylvania and the Third Circuit Court.

5. Obstruction of justice. Mails from court are delivered not by USPS system; Defendants got to USPS to stop BRIEF mailing; Mail from court arrived after Plaintiff's BRIEF sent, states different requirement to what I mailed; Mails from courts got theft, so Plaintiff may miss deadline for response. Defendants forcedly sent me to Queens Hospital to miss deadline for rehearing application. Due to reasons mentioned above, I respectfully submit my petition to U.S. Supreme Court.

REASONS FOR GRANTING THE PETITION

1. Conflict decision between 3rd Circuit Court and U.S District Court Western District of Pennsylvania.
2. The Court of Appeal departed from the accepted and usual course of judicial proceedings, and sanctioned such a departure by a lower court, due to some factors outside of courts which are under investigation by D.O.J General Inspector Office.

CONCLUSION

The petition for a writ of certiorari should be granted.
