QUESTIONS PRESENTED

1. There are no military guards beating the Petitioner, restraining him, no persons hitting him bloody, keeping him behind locked doors visibly, shouting at him awful things, taking him to public places and telling the public to hurt him and spit on him and call him names and throw things at him. This is because these things today are done using technology causing the exact same things covertly using advanced technology and unregistered medical devices used to abduct children from Eastern Europe to torture publicly while spreading secretly the word that it is being done to the Petitioner. So, you can have child abducted captives walking around in public alone year after year without being visibly held captive and restrained and beaten, but doing the exact same thing using medical devices, years of isolation, technology, and social media, emails, phone calls where you can push a button to cause pain, and create sounds to cause intense pain in the Petitioner causing intense harm, holding him captive in public torturing covertly for lifetimes, being forced to walk around alone year after year every day.
2. The petitioner is a person presently held a captive in complete isolation using unregistered medical devices and medical procedures, which in the Pittsburgh PA USA area seemed to be often used to abduct children from Eastern Europe and to hold them captive in public settings, given the Federal Government Ranks this area at #9 for child trafficking activity. Such as the Petitioner is in an apartment in Pittsburgh PA USA at this time, but in incredible pain, suffering every second, every minute, every day, induced by medical devices, and medical procedures, while having zero human contact, isolated completely for many years. Kept isolated by being surrounded by child trafficking paramilitary groups that are used to hold child abducted people in the area as captives, by blocking all social medial communication, all email communication, all communication, and replacing it with harassing communication every minute to induce intense fear and captivity. While creating incredibly negative information around the Petitioner so that everyone crosses the street and says horrible things when seeing the Petitioner. While many persons create harassing things to impart to the Petitioner since many people spread the word secretly that the Petitioner was child abducted from Eastern Europe for public enjoyment of hurting him, harassing him every which way possible without any consequences. While the Petitioner has birth records from Eastern Europe associated with countries in Eastern Europe, being chased around the greater Pittsburgh PA USA area with that identity, alone isolated, with unregistered medical devices used for torture frequently used to abduct children from Eastern Europe to Pittsburgh PA USA for public torture, enjoyment, execution, and forced labor.
3. In Jun of 2021 USCIS Monroeville PA USA Field Office filed a Motion trying to take away citizenship granted to the Petitioner, which was part of a sequence predetermined ahead of time. And, it was planned to take after several attempts were taken to create highly negative false information around the character of the Petitioner. This is so that after highly negative information is created around a person and made public by child trafficking paramilitary groups operating in the Greater Pittsburgh PA USA area, purposefully for manipulating Federal Documents, they can carry it out more easily as no one would care if they do this to a person of bad character. While also manipulating records in Europe at the same time, trying to validate false backstories created for children abducted to here in the 80s and 90s from Eastern Europe.

4. Many child traffickers were openly publicly targeting the Petitioner at the time, and still now, trying to mount falsified negative information about the Petitioner as the Petitioner had to file numerous Police reports identifying these incredible child trafficking rings operating in the Greater Pittsburgh PA USA area, since this area is listed at being #9 in child trafficking according to the U.S. Federal Government, and these persons child abducted the Petitioner from Eastern Europe to the Greater Pittsburgh PA USA area in the 90s for forced labor, torture, ransoming, public torture and posting his “snuff” torture pictures online for others to see.
5. USCIS Motion was planned to be after after many years of incredible captivity since a minor child, in forced labor, and being forced to do many things in captivity since a minor child, including writing letters back to Eastern Europe when America was bombing Yugoslavia, when the minor Petitioner was taken around in the Greater Pittsburgh area from party to party and gathering to gathering, using medical devices, as a party trick torturing him in public at parties for enjoyment. Then being forced to write letters back to persons in Eastern Europe when America was bombing the area he was connected to and was child abducted from along with thousands of children. Sending back torture letters and pictures for many years even while on campus at the University of Pittsburgh, Carnegie Mellon University, The National Energy Technology Laboratory, and using their International Communities to carry out these incredible violations of human rights in public view daily ongoing for over a decade, even presently.
6. The Petitioner has handed out over 60,000 fliers alerting the International Community of the University of Pittsburgh, Carnegie Mellon University, The National Energy Lab, University of Pittsburgh Medical Centers, and Allegheny Health Network Medical Centers and the surrounding areas to these incredible violations of human rights of children abducted from Eastern Europe in times of conflict. Mass child abducted using medical devices, medical procedures, false medical diagnosis, and false records and publicly tortured and executed while held captive in isolation and having records, identities, and everything attached to Eastern European countries and being forced to go around screaming in pain names from Eastern European countries and names of Eastern European countries publicly every day in a very public and very visible torture execution sequences while in total captivity.
7. It is estimated that since the Chernobyl Disaster over 72,000 children have been brought to the United States from Eastern Europe through various back-channels, forcibly transferred from Conflict Zones which is a violation of International Law, The Geneva Conventions, and The Conventions on Genocide. Transferred to the United States for Forced Labor, Public Torture, and Public Executions. Since Chernobyl most countries in Eastern Europe experienced serious government changes and even serious wars such as being bombed by America as in the case of Yugoslavia, creating an instability in an entire region during which over 72,000 children were abducted and forcibly transferred to the United States for these public “snuff” movie torture routines, as detailed on the website the Petitioner created to document on <http://iJakab.News>

The Petitioner filed petitions in lower courts, and the appellate court trying to undue the USCIS Monroeville PA USA Field Office child trafficking and child abduction routines, but the lower courts did not dare to undue the actions of the USCIS Field Office due to very serious child trafficking gangs operating in the Greater Pittsburgh PA USA area, as this area is ranked #9 in the Nation for Child Trafficking, Human Trafficking, woman trafficking, forced marriages, and

related incredible violations of human rights, and violations of International Law, where children are routinely abducted to from Eastern Europe for public torture, rape, forced labor.

STATUTES AND RULES

- According to Article 50 of the 1949 Geneva Convention on the Protection of Civilian Persons in Time of War, occupants have no right to change the civil status of children.

SEC. 1 GRIEVANCES

1. The Petitioner has absolutely no hopes in life, can never do anything normal, and has never done anything normal. Has never been on a date, never had the chance and never will have the chance to be on a date, and never had any normal human interactions, never had a friend, and never will have any normal human interactions, or meet a woman and marry and have children voluntarily as would be set out for a human being in the U.S. Constitution despite being in the United States since January 6th, 1996. Everything that will take place will be by force in slavery captivity using unregistered medical devices and medical procedures. Since a small child in Eastern Europe in the 80's, and maybe even before birth, the child Petitioner was in the hands of American Child Slave Traders at child slave breeding sites in destabilized parts of Eastern Europe. Where many woman and persons were held captive for many years to Eugenics make children from them to child slave ship to the United States using child slave trading routes operated by the Pittsburgh PA USA Heinz Children's Foundations, operating through the Ligonier PA USA Bethlen Hungarian organization, using the organization's connections and ties in Eastern Europe. When the Petitioner goes to public places, many people tell other people where he is, and he is tracked down by people wanting to hurt him, and see other people go to where he is to hurt him in public outside of police help, any help, as even police officers, government and state employees take part in these public tortures, while people take pictures and post them online, and tell many people from Europe and Eastern Europe and show them these torture “snuff” pictures of the Petitioner child abducted from Eastern Europe.

11. Medical devices and medical procedures are used on the Petitioner to create high sensitivity to things, such as the apartment he is placed in has many knocking sounds and every knocking sound causes intense pain in the Petitioners face and hands and limbs, causing complete pain at all times and many people come and create these things while he is inside of his apartment knowing that medical alterations and medial devices were given to the Petitioner so that these things will cause incredible pain in the Petitioner while inside of this apartment, trapped. The Petitioner tried moving to a different apartment but was not able to, and he is completely trapped, isolated, and blocked in every direction. While his internet communications, emails, phone, and social media are being overtaken by paramilitary people who created this torture terrorist cell to hold the Petitioner a captive inside of for many years, since a minor child, are sending information in a brainwashing way to expose the Petitioner to information they want to expose him to, while trapped inside of this apartment for many years, being tortured in incredible pain every second of every day, and then tracked down in public every second of every day and hurt and also fed brainwashing information every day. While having manufactured Eastern European names and records publicized everywhere publicly and openly.
12. While in captivity with a medical device the Petitioner was even raped for children and they were hurt on purpose by the captors to make them disabled in addition to hurting the Petitioner, and torture pictures of the Petitioner along with hurt newborns were also posted online on social media, and the Petitioner was forced to contact people in Europe and Eastern Europe repeatedly for many years showing them these “snuff” torture pictures. While being in forced labor at the University of Pittsburgh and the National Energy Lab and Carnegie Mellon University, being displayed as such in front of the International Community for many years as this, badly hurt.
13. Before being child abducted to the United Sates from Eastern Europe, the Petitioner was a child captive at a children’s camp in Eastern Europe which was used to hold abducted children being prepared for transport to America. There, the Petitioner was introduced to other minor children who he was told were his siblings, about 13 or so total Jakab children or maybe more. Even presently now in Pittsburgh PA USA, the petitioner receives messages on social media, and by email and by phone from people pretending to be these persons the Petitioner never saw since 1990, but have been communicating with the Petitioner sending social medial, email, and phone messages to him all this time, as part of the torture and brain washing terrorist sequence the petitioner is being held captive inside of using medical devices and incredible things.
14. After being brought to Ligonier PA USA as a minor child, people said that the Petitioner was too white so they fed the petitioner strange drugs to make the Petitioner less of a white minor child, using chemical treatments, drugs, and was left outside as a child in intense Florida sunlight for weeks with drugs and chemical treatments. Was taken to Florida for a couple of weeks once a year where the Petitioner was further tortured, was paraded around while in captivity being toured with a push of a medical device button at parties as a party trick.
15. The Petitioner has handed out over 60,000 fliers alerting the International Community of the University of Pittsburgh, Carnegie Mellon University, The National Energy Lab, University of Pittsburgh Medical Centers, and Allegheny Health Network Medical Centers and the surrounding areas to these incredible violations of human rights of children abducted from

Eastern Europe in times of conflict. Mass child abducted using medical devices, medical procedures, false medical diagnosis, and false records and publicly tortured and executed while held captive in isolation and having records, identities, and everything attached to Eastern European countries and being forced to go around screaming publicly in pain names from Eastern European countries and names of Eastern European countries publicly every day.

16. It is estimated that since the Chernobyl Disaster over 72,000 children have been brought to the United States from Eastern Europe through various back-channels, forcibly transferred from Conflict Zones which is a violation of International Law, The Geneva Conventions, and The Conventions on Genocide. Transferred to the United States for Forced Labor, Public Torture, and Public Executions. Since Chernobyl most countries in Eastern Europe experienced serious government changes and even serious wars such as being bombed by America as in the case of Yugoslavia, creating an instability in an entire region during which over 72,000 children were abducted and forcibly transferred to the United States for these public "snuff" movie torture routines, as detailed on the website the Petitioner created to start documenting these atrocities committed in the United States on abducted children in public view daily on <http://iJakab.News>
17. The Petitioner is one of the 72,000 forcibly brought to the United States from Children's Camps Directly Connected to Conflict Zones in Eastern Europe and areas undergoing significant government collapses and changes, where there was no central government, no police, and where American Paramilitary Groups Created International Children's Facilities using Children Charity Organizations for the purpose of falsifying children's records, and creating false records to transport thousands of children from Conflict Zones to the United States, Circumventing International Law, The Geneva Convention, and The Genocide Convention given the lack of counterweight oversight at the time, the United States Being Solely an All Powerful Entity.
18. Woman deemed valuable abducted fleeing the Chernobyl Disaster were held captive at nearby child slave breeding sites and were forced to birth multiple children to later transfer to the United States using these developed child slave trading routes. Given that the Chernobyl Nuclear Power Plant got the brightest minds from all around, people related to Einstein, and many famous scientists. During this chaos the child slave traders used the opportunity to hunt down and abduct Einstein connected and Einstein like men and woman to be used on these Eugenics child slave breeding farms to create child and human slave shipments to the United States, as the Petitioner was to greater Pittsburgh PA USA using unregistered medical devices.
19. After transport to the United States, the minor Petitioner was given unregistered medical devices and undocumented medical procedures to hold captive in public view, covertly. And, at the same time was photographed and was forced to write letters back to Eastern Europe when America was bombing Yugoslavia as a means of war using abducted children held captive and tortured, photographed and forced to write letters back while their homes were being bombed.
20. Due to multiple American Organizations competing over children at these facilities, the Petitioner has several birth certificates created by competing Child Charity Organizations used to abduct children, using child charities as fronts to openly operate in conflict zones unhindered.
21. Recently, the USCIS Monroeville PA USA Field Office initiated a Motion trying to take away Citizenship granted to the Petitioner. This Motion filed by the USCIS Monroeville PA USA Field Office was due to child traffickers and child abductors operating in the area, having planned sequences for children they abducted from Eastern Europe. And, carrying out these planned document manipulation sequences used to trap persons, hold children and persons captive in public view, and used to create forced labor conditions by inducing captivity and fear for forced labor, and for carrying out paramilitary operations by torturing abducted children.

22. The Petitioner filed petitions in lower courts, and the appellate court trying to undue the USCIS Monroeville PA USA Field Office child trafficking and child abduction routines, but the lower courts did not dare to undue the actions of the USCIS Field Office due to very serious child trafficking gangs operating in the Greater Pittsburgh PA USA area, as this area is ranked #9 in the Nation for Child Trafficking, Human Trafficking, Forced Marriages, and related incredible violations of human rights, and violations of International Law, where children are routinely abducted to from Eastern Europe for public torture, rape, forced labor, and execution.

SEC 2. TIMELINE OF EVENTS

1. In January of 1996, in a planned child abduction sequence, the minor Petitioner was taken to the US Embassy in Bucharest Romania shortly after the Petitioner was issued a traveling passport in this government destabilized country, by child trafficking paramilitary groups having total control of government offices and using them to abduct children from anywhere in Eastern Europe and were able to print any false document here for transport. The US Embassy in Bucharest Romania stamped the child abduction passport printed for the minor Petitioner with a planned stamp, planned ahead of time as part of a child abduction sequence. It is unclear how they were able to do this given the minor child had several different birth certificates at this time by several difference child abduction organizations competing over children to abduct. This stamp allowed the minor Petitioner to be abducted out of the area, and the stamp was purposefully selected ahead of time with planning and execution and the person doing the stamping was Ambassador Susan S. Jacobs working for First Lady Hillary Clinton transporting child abducted and Eugenics birthed children in total captivity birthed as farm animals for transport by American child slave traders to America for public torture, forced labor, execution.
2. The minor Petitioner was then taken to London England. While in London the minor Petitioner's flight was delayed several days during which time the British adoptive parent was told to take their new child to visit family in England showing them their new adopted minor child. Given that everyone knew the minor Petitioner was being child abducted for incredible evil things from children's camps connected to war zones in Eastern Europe, the Petitioner was not taken home to visit family in England despite being given many days to do so due to flight delays. Which clearly indicated knowledge of wrongdoing and knowingly being participant in incredible wrongdoing, Eugenics child trafficking and Eugenics child slave trading.
3. From London the minor Petitioner was somehow flown to Pittsburgh PA USA, even after these clear red child abduction flags, it is so corrupt, and entered the United States on January 6th, 1996 as a minor child, child abducted but in the legal custody of adoptive parents, according to Hague International Adoption Standards and American Passport Stamps obtained for this child abduction, being able to obtain every stamp and standard to carry it out. One British Citizen, and one American citizen adoptive parents. In April of the same year in 1996, the British citizen parent naturalized while having legal custody of the Petitioner, a minor at the time.
4. In accordance with former INA 321, the Petitioner became a United States Citizen when the British Citizen adoptive parent at the time married to a US Citizen, naturalized, while having legal custody of the minor Petitioner. The Petitioner was in their legal custody according to USCIS Monroeville PA USA Child Trafficking Field Office granting a Permanent Resident card, according to Hague International Standards obtained using falsified child abduction documents, US Embassy Stamps in child abduction capital Bucharest Romania, where the entire government was overtaken by American child trafficking paramilitary groups after recent

total government collapses, where First Lady Hillary Clinton was validating child abductions using the Romanian Embassy and Her Ambassador Staff Susan S. Jacob.

5. Countries from where children were abducted from were Germany, Poland, Czechoslovakia, all of the Soviet Union, Northern Europe, Ukraine, all of Yugoslavia, all of Hungary, and basically all of Eastern Europe to Romania area where these child slave trading paramilitary groups operated facilities and entire regions holding abducted children captives there for years for processing to be transported to the United States for forced labor, child slave labor, forced marriages, forced everything as they are child slaves being transported as in the case of the minor Petitioner with planned slavery medical procedures and unregistered medical devices.
6. Moreover, upon entering the United States the minor Petitioner clearly stated to everyone that he was in European Police Custody for many years who investigated the Children's Facilities and Pittsburgh PA USA Child Charity Organizations to find that children were being abducted, children were even birthed from abducted women and men in conflict zones held captive for as long as 10 years, to make children from them to place into these facilities increasing numbers of available children to transport to the United States along the child slave trading routes developed at this time using the Pittsburgh Heinz Child Foundation which oversaw the Operations of the Ligonier PA USA Hungarian Bethlen Children's Organization using their Hungarian ties in Eastern Europe to covertly create and operate these child trafficking centers. Where children were birthed as farm animals, children were abducted from anyone in highly destabilized areas, where there was no police or central government, and even local false records were created for children in these areas creating false identities and even backstories for children being abducted to the United States. Where at this facility the Petitioner was held captive from about age 3 or 4, and possibly from even birth, and was taught languages, given names, given identities, backstories, everything as part of a child slave trading process to be shipped to the Greater Pittsburgh PA USA area bearing the name Zoltan-Zsolt Levente Jakab, for total exploitation in lifelong captivity conditions, using medical devices, falsified medical records, falsified everything planned ahead for a lifetime of slavery and captivity.
7. Upon entering the United States the Petitioner minor child stated many of these due to being in custody of European Police who tried stopping these activities at the time, given the scale. Despite saying these, and despite being taken to many police stations and government officials in the area after stating these, the USCIS Monroeville PA USA Field Office provided a Permanent Resident Card to the Petitioner in January of 1996, validating his child abduction as legal, and giving him legal status in the United States in the custody of the adoptive parents who were used as child trafficking mules, and the child abductors organizing these were even able to obtain Hague Standards to child abduct the minor Petitioner from children's camps in conflicts.
8. Governments were so highly destabilized in Eastern Europe, having little police and central government, that even Hague Adoption Documents were created for the Petitioner, in accordance with International Standards, even containing false multiple birth certificates manufactured for child abductions, and even containing falsified backstories created for child abductions, backstories still in existence and validated by the fact the Hague International Standards were used to validate those falsifications created for mass child abductions and child trafficking, bearing U.S. Embassy Stamps by First Lady Hillary Clinton Staff Ambassador Susan S. Jacob as validating entities and seals, validating child slave trading from Eugenics children making facilities operated by American paramilitary.
9. The petitioner remembers the fear the persons processing the documents for this child abduction were showing, trembling, terrified, misspelling things to indicate their unwillingness to do this. Miss-printing birth certificates, and mistyping things as Eugenics child slave trading is serious.

It was clearly evident to the minor Petitioner that American child slave traders were using incredible force to make the local persons in a highly stabilized country to their bidding, using incredible threats of force, killings, executions, and arrests, instilling incredible terror.

10. The Petitioner stated to USCIS Monroeville Field Office in Pittsburgh PA USA, and everyone that he was child abducted and the other children he was told they were his siblings were also child abducted using the same methods as were used on him, and they are in the Dallas Texas USA area, and were brought to the USA many years before the Petitioner was. Despite stating this, the other children and the minor Petitioner were not reunited, and reconnected with their biological families they were abducted from in Eastern Europe, but were hurt even more, and given medical devices and medical procedures, and falsified medical records, to hold them captives in exploitation with even stricter captivity methods.
11. Because this is what child slave traders who operate Eugenics child slave breeding sites do when their child slaves don't behave accordingly after purchase and transport for public torture, forced labor, ransoming, execution. Hurt them more and hold them captive using more force.
12. Over the years, the Petitioner was held captive the entire time using medical devices in intense isolation, being surrounded by child trafficking paramilitary groups who regularly caused harm and took pictures and forced the Petitioner to contact many persons in Eastern Europe showing them torture pictures on social media, using emails, and various forms of communication regularly, still to this day as it is presently ongoing.
13. In addition, the Petitioner was forced to father three children in captivity and isolation using medical devices, and those children were purposefully harmed and pictures were taken and posted online. And, the Petitioner was forced again to contact many persons in Eastern Europe showing them torture pictures posted online, and the Petitioner was forced to post torture pictures online regularly and contact persons in Eastern Europe regularly while in captivity using medical devices, being in forced labor conditions at the University of Pittsburgh in Graduate School being forced to perform forced scientific labor, publish forced scientific articles, and incredible horrible things. And after the University of Pittsburgh, the Petitioner was transferred in captivity to the National Energy Technology Laboratory where the same under even worse conditions undertook, under incredible forced slave labor using captivity, medical devices, and isolation always surrounded by forced labor child traffickers hurting him in isolation to perform slave labor. Always in complete captivity of the paramilitary groups who had possession of the Petitioner since a minor child child abducted to here for this purpose. The Petitioner was forced to write torture forced labor scientific journal articles while at the University of Pittsburgh, and while at the National Energy Laboratory while being kept in captivity in isolation using incredible pain induced using medical devices ever since 1996.
14. Presently the Petitioner is in an apartment in Pittsburgh PA USA, with zero human contact for many years, being incredibly hurt with unregistered medical devices used to abduct children to the Greater Pittsburgh PA USA area for these types of activities. The Petitioner has not seen the three hurt children he was forced to father in captivity using medical devices forcing him and holding him captive in over 6 years, after they were also tortured. The children were even purposefully hurt to make them ridiculous as a joke. When the Petitioner was a minor child in 1997, when America was bombing Yugoslavia, and when the Petitioner was taken around in the areas using medical devices for public torture, many persons told the Petitioner that they will make sure the Petitioner will father an "insane clown posse" as they put it, surrounding the Petitioner with incredibly hurt children to force him to walk around ridiculous as a public torture joke, given the Petitioner was child abducted from Eastern European conflict zones.

15. The Petitioner is being forced to file these court proceedings, in complete isolation using incredible pain induced using medical devices, while being completely surrounded by paramilitary child traffickers holding the Petitioner captive since a minor child. In complete isolation with zero human contact, while being fed information though every possible method, using his social media, emails, text messages from American Paramilitary persons contacting him regularly sending information. Through American Paramilitary persons finding him and people like him publicly every time to provide false information as there are thousands of persons who were child abducted to this area from Eastern Europe, held captive using these methods every single day in this area, being tortured. This area has developed a massive paramilitary force that actively tracks child abducted persons such as the Petitioner at every time entering public space to create false information around the Petitioner and persons like the Petitioner for public execution, torture, child trafficking, and operating a terrorist cell in public with thousands of people in the Greater Pittsburgh PA USA area having thousands of persons child abducted to here from Eastern Europe held captive in terrorist cells, using false information, false identities, being connected to countries in Eastern Europe, being tortured and hurt every single minute using unregistered medical devices screaming in captivity.
16. The Petitioner is isolated in an apartment in Pittsburgh PA USA in front of everyone with zero human contact going on many years, being incredibly tortured with medical devices causing inedible pain every second in public view, while being sent around Greater Pittsburgh PA USA where many people come and take part in hurting the Petitioner in Public as everyone knows here that in the area Americans bring children here from conflict zones in Eastern Europe for these types of public torture and executions. Everyone takes part as there is no law, no police, even police officers take part, and government employees take part. The Petitioner tried filing police reports and police stations refused openly and publicly, and the same with government offices, state representatives, state officials, this area is so lawless openly. The Petitioner contacted every legal organization and every lawyer in the area to find no help but public torture, hurting, and execution openly in front of everyone training everyone publicly to know that they can partake in openly in these types of public executions without having to fear police, and legal actions against them.
17. These types of things are practiced so much in the Greater Pittsburgh PA USA area, regularly and openly creating incredible terror and fear in thousands of people living here, brought here forcibly for forced labor exploitation having records publicly tied to countries in Eastern Europe. Just as in the case of the Petitioner, he was given Hungarian documents at this child abduction facility operated by Pittsburgh PA USA child abduction paramilitary groups.
18. This effort is part of a planned sequence by the child abductors operating in the Greater Pittsburgh PA USA area, as part of a sequence of planned events. The Petitioner was dragged through family court where the child abductors and child traffickers tried to create family court related negative records around the Petitioner while in total captivity using medical devices and falsified records since a minor child.
19. Entire groups of people on Facebook who refused real contact but pretended on Facebook for decades since the minor Petitioner was child abducted to here, these child abduction contacts were created to falsify information around the minor Petitioner. Creating false information surrounding the Petitioner in captivity and creating a child slave trading surrounding and information system to hide the Petitioner in public using their false stories and unregistered medical devices, this area so deeply educated in these child abduction slavery practices.
20. The Petitioner subpoenaed many persons involved in holding the Petitioner a captive since a minor child in a recent family court proceeding after the Petitioner called the police trying to

stop the child torture and “snuff” picture posting in captivity horrible things. Many ex-military persons who forced their way into the life of the Petitioner demanding access to be in the life of children child abducted from Eastern European conflict zones to the United States. Many ex-military persons pretending family connections, many incredible things. It is so corrupt in America that the family court simply denied and hurt the Petitioner so that they can hide that information and prevent the Petitioner from asking them questions under oath in a court process. America is so corrupt that court rooms, judges, and affiliated persons hide and falsify information to prevent justice from entering, when there are a dozen ex-military persons coordinate the abduction of children from Eastern Europe, hold the child captive using unregistered medical devices, parading and torturing the child for decades, while posting torture pictures online and forcing the abducted child to write letters back home while America was bombing it in Eastern Europe in the 90s.

21. All done without justice outside of the law daily.
22. These persons created a profiting system of taking the Petitioner while a minor and now still to gatherings and parties and hurting the Petitioner with unregistered medical devices publicly and paying money to be able to do so. While incredibly hurting the Petitioner, while hiding and holding the Petitioner a captive in public view at the Ligonier Valley Highschool where every child knew that the Petitioner was child abducted for their torture and would do so routinely.
23. Then the Petitioner was hidden in plain view while in total captivity using unregistered medical devices and surrounded by persons creating false information around the Petitioner. Hidden at the University of Pittsburgh, Carnegie Mellon University, The National Energy Technology Laboratory, even at the United States Air force Bases in Texas, year after year, being taken from party to party, gathering to gathering being hurt and tortured publicly plainly in front of the general public in Greater Pittsburgh PA USA with the name Zoltan-Zsolt Levente Jakab, having identities, names, records connected to countries in Eastern Europe. And, it is still going on presently since every person in Pittsburgh PA USA knows this and takes part secretly every day.
24. The Petitioner tried subpoenaing many of these ex-military persons and government persons to get their testimony on record and their involvement on court record in torturing the Petitioner and the minor children the Petitioner was raped for while being held captive and their torture pictures posted online and was forced to contact persons all over Europe and Eastern Europe showing them all of these torture pictures year after year since January 6th, 1996.
25. It is so corrupt here and these persons are so above the law that obviously it was prevented from taking place and justice can never be served as these persons can openly organize children to be abducted from Eastern Europe to here for public torture and execution outside of the law on public display taking place daily year after year in front of police and everyone.
26. The Petitioner since a minor child entering the United States on January 6th, 1996 was being steered towards working in a Research Lab at the University of Pittsburgh in Forced Labor Conditions, while in captivity with unregistered medical devices, being tortured and his torture publicized regularly, being posted publicly online and send back to Europe.
27. The Petitioner was always next to Churches and Organizations for decades where persons that were directly involved in coordinating the transportation of the minor Petitioner are present in persons even to this day, doing things in the background, having connections to local governments, local police, local persons in politics, and using those connections to create falsified police reports for the Petitioner, holding the Petitioner a captive, forcing the Petitioner to undergo medical examination, forcing the Petitioner to father children while in captivity using Unregistered Medical Devices. Being the front operatives for paramilitary organizations and groups operating through churches and child charity organizations, while carrying out

medical child trafficking, child trafficking, and child Eugenics slave trading, forced labor, and ransoming and incredible horrible things with abducted children from Eastern Europe.

28. The Petitioner was at the University of Pittsburgh from Undergraduate to PhD by force in captivity, next to Bellefield Presbyterian Church Operating a Prism International Organization having persons that were directly involved in persons with these child transporting organizations operating in Eastern Europe and children's camps where the minor Petitioner was being held captive as a minor child in Eastern Europe. Bellefield Presbyter Church next to the University of Pittsburgh Engineering and Physics Building literally has persons who work there and work for the Prism Organization that were present in Eastern Europe in children's camps when the Petitioner was a child in those camps. The Petitioner was even raped for children in their shadow and forced to live in Swissvale suburb of Pittsburgh PA USA next to a Priest whose wife worked for the Swissvale township and the Priest directly connected to persons from Bellefield Church and the International Prism Organization using Swissvale Police and Township government creating false police reports, and false evidence around the Petitioner while being held captive with Unregistered Medical Devices by the extension of these persons manipulating things in the background, while keeping the Petitioner isolated alone a captive while on Campus of the University of Pittsburgh and the National Energy Technology Laboratory from 2002 to 2017. Conducting medical experiments on the Petitioner, forced breeding in captivity using Unregistered Medical Devices, forcing him to father children who were harmed on purpose and torture pictures posted online and sent to Eastern Europe.

29. While in isolation strange persons kept showing up in the life of the Petitioner who disclosed having connections and affiliations with Bellefield Presbyterian church and the Prism organization, being front operatives of Paramilitary child slave traders operating the Ligonier Bethlen and Heinz Charity child slave trading network in Greater Pittsburgh PA USA.
