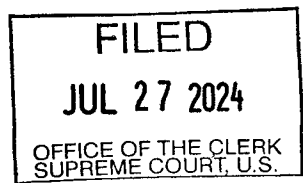

After 14 years of holding off multiple criminal foreclosures actions initially by failed criminal mortgage lender CountryWide Home Loans, Inc. and were responsible for the 2008 collapse, we have been removed violently with battering rams and assault rifles from our places of business and our homes having two physical addresses for which the respondent - United States Bankruptcy Court for the District of Oregon is now ultimately responsible.

I have lost every possible source of work that was provided by living on a farm with unlimited sources of income including the Air B-n-B that was reliable for sustaining the general expenses not including disputed current holder of the Note, verifying the proper assignee of the Trust Deed as promised by the bankruptcy court and then never provided for that under a separate notice per (Doc 124) Filed 06/01/20 prior to dismissal of my case.

I am living in fear of my life after the latest criminal transfers of our farm on 1-31-2023 & 6-27-2024.

I declare under penalty of perjury that the foregoing is true and correct.
