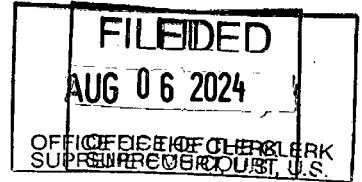

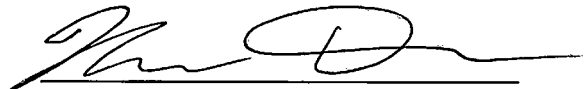

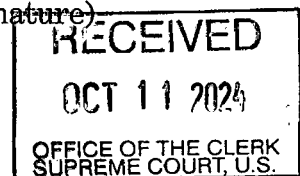

**AFFIDAVIT OR DECLARATION

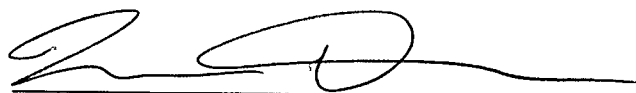
