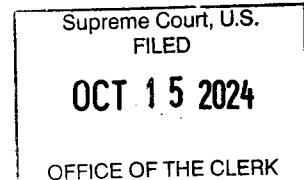

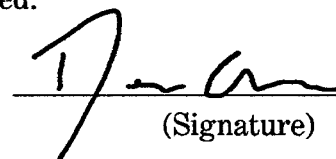

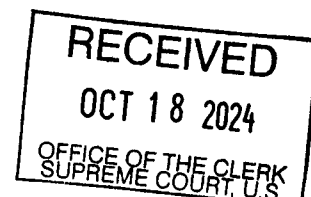

**AFFIDAVIT OR DECLARATION

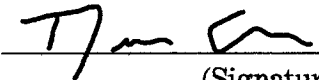

These acts have caused me to avoid the road ways, miss job opportunities and economically affected and deprived me of any pursuit of happiness. These actions are more fully expressed in a lawsuit filed (reasonable fears) in which I accused the State of Georgia of breaching the social compact for which I alleged I am a beneficiary of.
