STATEMENT OF FACTS/BACKGROUND

I encountered something traumatic working for the Department of Education that never happened to me before and if you've encountered something traumatic its like an abyss, you've fallen into it, and the reason you're still upset is because you don't know why you've fallen into it. So, your brain, your mind, your soul is warning you, says , "you fell into a pit, buddy" and you don't know why...."and, so you can fall into it again", and so "Im not going to let you forget it", ...you have to figure out why you fell into that pit. So, I asked my UFT rep at the end of my career while I was being illegally fired, and he said that my bosses did not like me because I did my job too well..He, Klaus Bornemann told me I would have made a better career in Hollywood and that I did not belong in teaching..I did not understand that since I

dressed like a teacher and I was an average looking person. At one point when I needed his help regarding the papers he discarded he and got nasty by calling me an "old", and words that transcribed into meaning "hideously ugly" woman. I was so confused at that and that my boss grabbed my buttocks, beat me up and verbally/emotionally and physically threatened me all the time, and her best friends on the job she got after me (they mobbed me) brainwashed me that I was a bad person who deserved to be forced into therapy, that I was so bad I deserved to get the worst programs to teach the teens, that I deserved to be forced to take psychotropic drugs to keep my job, and that I deserved to be forced into multiple hospitalizations.

NEW EVIDENCE

The following is a list of new evidence of my sworn testimony

1.) A woman I called a friend named Lisa Jackier Glazer I had kept in touch with for about 24 years committed identity theft against me that I just got hard evidence of at the end of the summer in 2024, so I had to report it. She stole my Masters degree either by obtaining it from Federal Court in my case that is

available to the public or when she slept over my mom's home years ago. She forged it to obtain \$10,000 more a year teaching in Michigan. I had met her in Florida during my first nervous breakdown (a major weakness of mine) after the NYC DOE aid attacked me at John Jay High School. I moved to Florida for Job related stress (from NY)..... So, I feel strongly that that if The NYC Dept. of Educ. (and the body of).did not abuse me then I would have had my wits about me and this parasite, Lisa (from Michigan) would not have been able to torment me in recent times and on goingly. Also. If I did not have to do this case, because my bosses treated me in a professional and legal way my information would not have been available onlineby paying about \$40 to purchase or by going in person to the Federal Court pro se office and paying for a copy after reading my filed paperwork evidence and exhibits , anyone could get my information.

The trauma of this is really caused from the abuse I faced at the NYC DOE because when you have low self esteem and are forced on psychotropic drugs, it is a weakness others can detect.

3.) Restraining Order against my father, Raymond Gindi I got a restraining order against my father in

2009 right after getting one from my husband because my stress from being fired when my boss knew I was going through a divorce (and other reasons she fired me pertaining to my going to Human Rights about sexual abuse, etc. and Special Commissioners Investigations about her grade tampering) at the same time was overwhelming. I was extraordinarily afraid of him during this nervous time.

4.) My father keeps calling and calling and calling so many times for me to visit him as he is 85 years old and lives about 40 minutes away but I cannot because of this case that I had to print thousands and thousands of pages of motions, replies and petitions for and the trauma of my bosses abusing meso overwhelmed cannot even get my car fixed....did actually go two hours by train and busses to see -- him,that I need a judgement in my favor so I could move on, I cannot focus on the needs of my dad in his senior years and it is in part due to this case's

fault. One of my dad's nasty messages that is because I cannot see him and because I cannot take his insulting me when he makes fun of me that I am a failure in life gave me a wakeup call to how he sees my ongoing trauma due to the abuse by the NYC DOE. He told me off that I blame my friends (and he said "cousins and family" in the past regarding a similar argument)for losing my job at the NYC DOE. . Those 5 times I was admitted to the hospitals still give me fear and panic, especially The one in NYC called Gracie Square which had showers and windows that looked like something out of a horror movie. A filthy dark and old place. Attached is my dad's voice recording to me I had transcribed and you must know that my dad never curses so this voice recording really caused me more trauma. It happened right before the holidays that I missed, also. My dad won't stop harassing me and it's ruining my life!

5.) Transcript of Raymond Gindi by Transcript Puppy Company":

Man: Hi, Lisa. How are you? There's an old saying,

absence makes the heart grow fonder. That being said, since we had a terrible conversation with friendships and uhh mind your own business, and don't tell me this no- that's okay, that's where you are. I think that has a relationship between how you succeed in your legal affairs. If you don't, then you take it out on friends.....

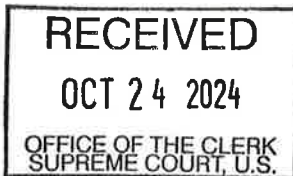


