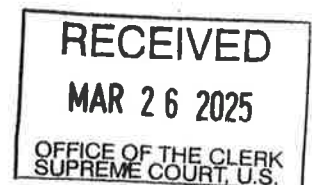
PETITION FOR REHEARING:
