a peace officer of the Lexington Police Department, that there is probable and reasonable cause for the
issuance of this Search Warrant as set forth in the Affidavit attached hereto and made a part hereof as if fully set
out herein; you are commanded to make immediate search of the location known and numbered as:
2852 Yellowstone Parkway, Apartment D, Lexington, KY 40517

and more particularly described as follows:

2852 Yellowstone Parkway Apartment D is a multi-family four-plex located on the Southeast side of Yellowstone Parkway. 2852 Yellowstone is a tan sided building with a grey asphalt shingle roof. Apartment D is located to the rear of the building. As you are facing the rear of 2852 Yellowstone Parkway, Apartment D is located on the right side of the building. Apartment D has a brown door with the letter D permanently affixed to the center of the door. Apartment D also has the letter D permanently affixed to the post of the porch covering the doorway.

and/or in (a) vehicles(s) described as:

A 2007 four door Chrysler, Silver in color. The listed vehicle has a KY registration plate which is affixed to the rear bumper of the vehicle, labeled as 108-GXB. The vehicle's vin numver is 2C3KA53G77H682414. The vehicle is registered to Antwone M Sanders.

and/or on the person(s) of:

Antwone M Sanders. DOB- Redacted Redacted. Mr. Sanders is a male black, approximately 6 feet, 1 inches tall. His approximate weight is 230 pounds. Mr. Sanders has black hair and brown eyes.

for the following described personal property, to wit:

Heroin/Fentanyl, Notes, Letters, Writings, Documents, Monies, Safes, Recordings, Cell Phones, Data within cell phones, Photos, Drug Paraphernalia, or whatever type of drug the presence would tend to indicate the illegal use of, possession of, or trafficking in a controlled substance as defined by Kentucky Revised Statutes.

and if you find same or any part thereof, you are further commanded that the property be seized and brought forthwith before me or any other court in which the offense in respect to which the property or things taken is triable, or retained in your custody subject to order of said court, such property being held against the peace and dignity of the Commonwealth of Kentucky.

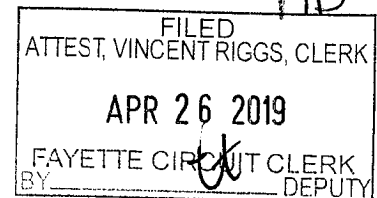

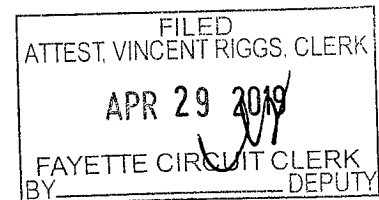
Comes the Affiant: Officer Brandon Hazlewood

a peace officer of the Lexington Police Department, who personally appeared before the undersigned and being first duly sworn, now on oath deposes, affirms and says that he now has and there is reasonable and probable grounds to believe and Affiant does believe that there is now at the location known and numbered as:

2852 Yellowstone Parkway, Apartment D, Lexington, KY 40517

and more particularly described as follows:

2852 Yellowstone Parkway Apartment D is a multi-family four-plex located on the Southeast side of Yellowstone Parkway. 2852 Yellowstone is a tan sided building with a grey asphalt shingle roof. Apartment D is located to the rear of the building. As you are facing the rear of 2852 Yellowstone Parkway, Apartment D is located on the right side of the building. Apartment D has a brown door with the letter D permanently affixed to the center of the door. Apartment D also has the letter D permanently affixed to the post of the porch covering the doorway.

Affiant states that there is probable and reasonable cause to believe and Affiant does believe that said property constitutes (check appropriate box or boxes):

Affiant has been an officer in the aforementioned agency for a period of 4 years and the information and observations contained herein were received and made in his capacity as an officer thereof.

On the 17th day of April at approximately 815 PM, affiant received information from /observed:

On 04-17-19, your affiant received information from a Confidential Informant (CI) that a subject by the name of Antwone Sanders was selling Heroin/Fentanyl from 2852 Yellowstone Parkway Apartment D, Lexington, KY 40517. The CI advised Mr. Sanders was a male black, approximately 6 feet tall and weighing approximately 230 pounds.

Acting on the information received, Affiant conducted the following independent investigation:

Within the last two weeks, Detective Brian Cobb and I met with a confidential informant to brief reference completing a controlled buy of Heroin/Fentanyl. Upon briefing, the CI and their vehicle were searched. No contraband was located during the search. The CI was provided police buy money and then proceeded to a pre-determined meet location to purchase heroin from a subject known as Antwone Sanders. Your affiant was able to use a police database to locate a subject named Antwone Sanders, DOB [REDACTED] matching the description provided by the CI. This photo was shown to the CI. They confirmed this is the same subject they know as Antwone Sanders who sells heroin /fentanyl from 2852 Yellowstone Dr.

The CI was monitored and observed getting into the suspect's vehicle. The vehicle is a silver, Chrysler with KY registration plate 108-GXB. The affiant monitored the controlled buy and observed the CI exit the vehicle after entry and returned to a predetermined location to meet me. The CI and their vehicle were searched again and no contraband was located.

The CI provided me a quantity of suspected Heroin/Fentanyl, which they advised they purchased from Antwone Sanders. Police personnel followed Mr. Antwone Sanders operating the above listed vehicle without stopping to 2852 Yellowstone Drive.

Within the last 48 hours, Detective Sinnott and I met with a confidential informant to brief reference completing a controlled buy of Heroin/Fentanyl from Antwone Sanders. Upon briefing, the CI and their vehicle were searched. No contraband was located during the search. The CI was provided police buy money. They proceeded to a pre-determined meet location to purchase Heroin/Fentanyl from Antwone Sanders.


Detective Hart was observing the residence of 2852 Yellowstone Parkway Apartment D. A silver, Chrysler 300 with KY registration plate 108-GXB was parked near the front door of 2852 Yellowstone Parkway Apartment D, Lexington, KY 40517. Detective Hart observed Mr. Antwone Sanders exit 2852 Yellowstone Parkway Apartment D and enter the silver Chrysler with KY registration plate 108-GXB. Officers followed the vehicle from this location uninterrupted to the pre-determined meeting location.

The CI was monitored and observed getting into the suspect's vehicle. The affiant monitored the controlled buy and observed the CI exit the vehicle and returned to a predetermined location to meet with your affiant. The CI and their vehicle were searched again. No contraband was located during the search.

The CI provided me a quantity of suspected Heroin/Fentanyl that was purchased from Antwone Sanders. Mr. Antwone Sanders never exited the vehicle during the transaction. The Silver Chrysler with KY registration plate 108-GXB was followed by police personnel from the meet location directly back to 2852 Yellowstone Parkway. Mr. Sanders exited the vehicle and entered apartment D.

Based on the information received and the surveillance that followed, it is believed that evidence of Heroin/Fentanyl trafficking will be located upon search of 2852 Yellowstone Drive Apartment D, Lexington, KY 40517.


Affiant has reasonable and probable cause to believe that grounds exist for the issuance of a Search Warrant based on the aforementioned facts, information and circumstances and prays that a Search Warrant be issued, that the property be seized, or any part thereof, and brought before any court and/or retained subject to order of said court, such property being held against the peace and dignity of the Commonwealth of Kentucky.
