I feel Im going to have to protest in Washington, DC for the answers Im seeking about my love one JP2022 And myself plaintiff Torana Yone Miller.

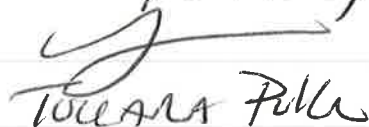
