
Dear Honorable Justices:

Pursuant to Supreme Court Rule 25.6, I write to inform the Court of intervening matter in the form of a related case pending in the United States Court of Appeals for the Ninth Circuit (Case No. 24-6057) that may affect the petition for writ of certiorari currently scheduled for conference on January 10, 2025.

While my petition before this Court focuses on the constitutional implications of California's application of its vexatious litigant statute, the pending Ninth Circuit case (No. 24-6057) challenges the underlying jurisdictional basis of the state court proceedings that gave rise to the vexatious litigant designation attempt. If the Ninth Circuit finds a jurisdictional defect, it would effectively unwind the proceedings to a point before the vexatious litigant issue arose, thereby mooted the question presented in my petition.

Given this circumstance, I notify the court as it may wish to consider relisting the case for a future conference or holding the petition pending resolution of the jurisdictional question by the Ninth Circuit.
