





*The Court of Appeals hereby passes the following order:*

### **A24A0250. DOUGLAS FLOURNOY v. THE STATE.**

This matter was docketed in this Court on September 5, 2023, and the initial brief of Appellant was due on September 25, 2023. To date, Appellant has not filed the initial brief, thereby violating the requirements of Court of Appeals Rule 23 (a) ("Appellant's brief shall be filed within 20 days after the appeal is docketed."). Failure to file a brief, unless the time for filing has been "extended upon motion for good cause shown, may result in the dismissal of the appeal[.]" Id. See also Court of Appeals Rule 16 (b) ("Failure to request an extension of time to file a brief before its due date may result in the dismissal of the appeal or non-consideration of the brief if untimely filed."). Therefore, due to Appellant's violation of Court of Appeals Rule 23 (a), this appeal is hereby DISMISSED.

**Filing Fees:** Filing fees accrue upon docketing a case, no appellant's brief shall be received for filing without the \$80.00 filing fee except for those Appellants who are: 1) incarcerated and pro se, 2) represented by appointed counsel/public defender, or 3) paupers (with court approved affidavit). If the appeal is disposed of before the brief is filed, the appellant must still pay the filing fee.

**Related Cases:** Attorneys must notify the Court if the above-styled case is related to any other case that is or was docketed in the Court. (E-filers file this as "Information" on the Docket. Hard copy submissions should be by separate letter to the Clerk.)

**Attorneys:** Note that Rule 46 requires that all submissions be via electronic format. E-filing instructions are found at [www.gaappeals.us](http://www.gaappeals.us).
