To promote transparency I suggest making this filing option a permanent rule alternative.

Or simply consider my savings hard-earned, my matter meriting review, and a waiver of fees applicable;

I've already offered my life in the specific bringing of this appeal, another \$300 or format discrepancies shouldn't make or break letting the truth reign supreme.
