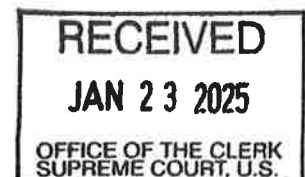

PETITION FOR REHEARING

NOW COMES PATRICK MICHAEL HACKETT Petitioning to Rehear the most succinct and efficient Petition for Writ of Certiorari ever written, regarding a matter in Iowa which deliberated for 5.7months, now accepted for application as the Guinness World Record for court deliberations, ethically obligated by experience over opinions; In that, inferior equipment shown during Grundy, IA's trial having been the rightful culprit; Due justice instead delivered upon Defendant Hackett:

Defendant-Appellant-Petitioner Hackett has, on every occasion, shown this equipment to be inferior, focusing specifically on the cement mixer's backwards-built design, where the engine has been placed in the rear with a steer axle, even faulty as described by Sgt Valentine on cross-examination. Where ignoring this evidence from the State's own and only witness shows the justice delivered as baseless, elsewhere in the country is seen these specific, uncommon vehicles driven by society's most marginalized members:

Anderson, SC's Creshaun Rainey, with a serious, lengthy criminal history speeds while on his phone, rear ending a 4door sedan, yet it's the obnoxiously-raised front bumper of this cement mixer due to the engine misplacement that interferes with airbag deployment for the car ahead, requiring 3-month old Jakai Govan's airlift and later death from cranial impact, despite proper securement: Jakai's car was completely driven atop of and smashed, like at a wrecking yard; Another stark example of how the makers of this cement mixer are shown as having had completely no idea what they were doing, in fact from the front bumper to the very rear.

Yet this is hardly news, or we would have more reputable drivers for these vehicles to begin with, rather than taking a long-term convict as last resort for a driver, in the case of Anderson, SC, April 5, 2024;

Coupled with another highway steering failure in Taylorsville, UT, June 6, 2024:

Pursuant to the 13th & 14th amendments, historical discrimination by means as these isn't lawful; An appeal is deemed necessary on these grounds, yet to safeguard the entire rest of the US Constitution as well.

Petition for Writ of Certiorari is necessary to credit Petitioner Hackett for relevant findings shown during trial, articulated in Writ for Certiorari, and elaborated on in this Petition for Rehearing. The Court's attention is requested to demonstrate a care for individual justice, the right to whistleblow, and to protect and promote America's intellectual property; that we're not inherently discriminative, that we don't consciously ignore public safety considerations.

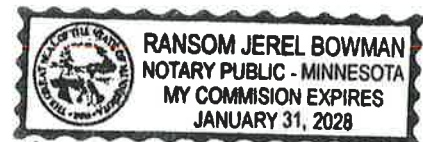
