
Motion to Proceed in Forma Pauperis

1. Petitioner desires to petition this Court for a writ of certiorari to review the judgment of the United States Court of Appeals for the Eighth Circuit affirming the United States District Court Court's decision.

ORDER

The Financial Affidavits of Defendants Daryl Strickland, Jr. and Rodney Tyrone Henry, demonstrate that, because they are financially unable to hire an attorney, they qualify for court appointed counsel.

Because is this a capital case,¹ the Court hereby appoints Latrece Gray, Nicole Lybrand, and John Williams from the Federal Public Defender Office to represent Defendant Daryl Strickland, Jr. Ms. Gray is death penalty certified to serve as lead counsel in a death penalty case. Ms. Lybrand and Mr. Williams will serve as co-counsel.

The Court hereby appoints attorneys Robby Golden, and Leslie Borgognoni to represent Defendant Rodney Tyrone Henry. Mr. Golden is death penalty

certified to serve as lead counsel in a death penalty case, and Ms. Borgognoni is death penalty certified to serve as co-counsel in a death penalty case.
