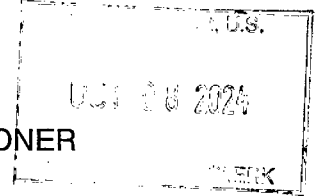

Claims can be backdated if you can show you were unaware of your rights to benefits and there were other circumstances outside your control."

STATEMENT OF THE CASE

The Illinois Department of Employment Security refused to grant my back pay of \$4,164.00, even when it was less than a year that I filed a Backdated form.

REASONS FOR GRANTING THE PETITION

Under legal Aid Online, Getting Unemployment benefits, it states that "you must file a benefits claim by the end of the first week in which you are unemployed. If you file later and do not request backdating, your claim will start the week it was filed. If you file after your first week of being unemployed but within a year, you can request the IDES backdate your claim. Claims can be backdated if you can show: You were unaware of your rights to benefits & there were other circumstances outside your control".

I applied for benefits in March, 2020. Illinois Department of Employment Security sent me a letter on April of 2020 to Certify on April 6, 2020. The letter did not explained that I had a year to receive any back pay if you miss the certification date. I called Illinois Department of Employment Security more than multiple times but due to Covid there was no answer. Finally, on December 2020, I spoke to a IDES representative & they ensured me that I will receive my back pay after filling their Backdating Questionnaire. They said someone will call me within a month. However, no one ever did. I deserve my back pay because their rule says less than a year.

CONCLUSION

The petition for a writ of certiorari should be granted.
