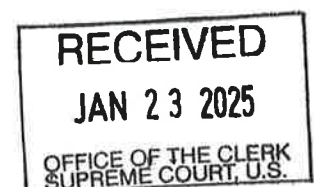

2. The inclusion of this evidence is to demonstrate that Defendant Nancy Ruth Landry was aware of the deficiency in the election systems in the state of Louisiana.




## **PRAYER**

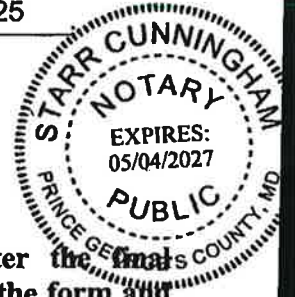
