MOTION

Petitioner Hakeem-Ali Shomo (“Shomo”) requests leave to file the attached petition for a writ of certiorari without prepayment of costs and to proceed *in forma pauperis*. This relief is warranted because Shomo sought similar relief below, and counsel was appointed to him during the earlier proceedings. *Sup. Ct. R. 39.1*. The Cuyahoga County Court of Common Pleas declared Shomo indigent and appointed trial counsel for him on June 6, 2022. *Entry attached at Apx. 0001*. After a mistrial was declared and Shomo’s motion to dismiss on the basis of double jeopardy was denied, undersigned counsel was appointed for the purpose of pursuing an interlocutory appeal. *Entry attached at Apx. 0002*. While the Supreme Court of Ohio would only appoint counsel for a full merits review following acceptance of a discretionary appeal under Ohio S.Ct.Prac.R. 7.09, that court permitted Shomo to file his appeal without filing fees or security deposits on account of the appointment of counsel by the lower courts under Ohio S.Ct.Prac.R. 3.06(B). Shomo’s appeal was rejected by the Supreme Court of Ohio on October 15, 2024, without the opportunity for appointment of counsel by that Court.

As further grounds for relief, Shomo has been incarcerated in the Cuyahoga County Jail without the opportunity to maintain employment during the years-long pendency of these proceedings. *Declaration in Support of Motion for Leave to Proceed In Forma Pauperis attached at Apx. 0003-8*. He therefore remains indigent and unable to hire counsel.

CONCLUSION

For the foregoing reasons, Shomo should be granted leave to file the attached petition for a writ of certiorari without prepayment of costs and to proceed *in forma pauperis*.


