MOTION FOR LEAVE TO PROCEED
IN FORMA PAUPERIS

PLEASE TAKE NOTICE that petitioner, Terrance Caldwell, respectfully moves for leave to proceed *in forma pauperis* in connection with the above-captioned petition for a writ of *certiorari*.
