CONSTITUTIONAL AND STATUTORY PROVISIONS INVOLVED

I entered a psychiatric facility and stayed for a seventy - two hour period in consecutive days. This is the reason why the Dept. of Justice has disabled my rights to own, and/or possession of any firearms. After learning my right was taken away, I then scheduled a court date in the Los Angeles County Superior Court.

In the proceedings, the judge asked me why I was in a mental health facility. I replied that it was my mother's idea. Then I asked him to direct that same question to my mother since she was present as I did in fact ask her to accompany me. The judge then referred the conversation to my mother. She then answered and stated a childhood friend of mine had recently became deceased and thought maybe I would become upset or behave differently. He (the judge) verbally mentioned in my favor and said since the Dept of Justice is involved that this matter was a case for the federal court system.

STATEMENT OF THE CASE

I do believe if communication had been more understanding, and explained for myself and family, my right to own and/or possession of a firearm would not be a matter for the courts.

REASONS FOR GRANTING THE PETITION

I am currently employed with my occupation being in security personnel. I would to advance my current career and become an armed officer.

CONCLUSION

The petition for a writ of certiorari should be granted.
