Dear Mr. Harris:

The petition for a writ of certiorari in the above-referenced case was filed on December 6, 2024 and placed on the docket on December 16, 2024. Respondent (and Intervenor below) General Drivers, Warehousemen and Helpers Local Union No. 89's response is due on January 15, 2025.

Under Rule 30.4, we respectfully request an extension of time in which to file Local 89's response to and including February 14, 2025.

An extension is necessary as pre-existing commitments will make preparation of an adequate response within the thirty days provided by the Rules difficult.
