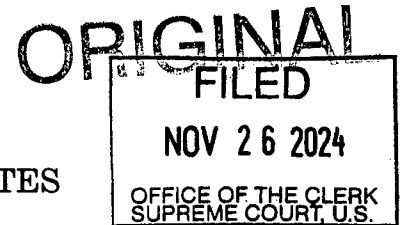

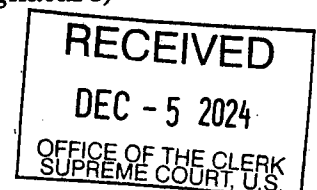

**AFFIDAVIT OF DECLARATION

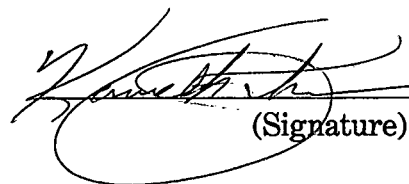
