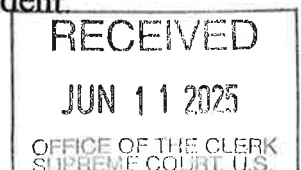

**PETITION FOR REHEARING**

Pursuant to Rule 44.2 of the Rules of the Supreme Court of the United States, Petitioner Amia Young-Trezvant respectfully petitions for a rehearing of the Court's denial of her petition for a writ of certiorari in case number 24-6602, which was entered on the docket on April 28, 2025. Petitioner seeks reconsideration on the grounds that there are intervening circumstances of a substantial and material nature that were not previously presented to the Court and that may affect the outcome of the case.

Specifically, since the filing of the petition, Petitioner has been subjected to what she reasonably believes is ongoing retaliation by Lone Star College System. Petitioner was wrongfully terminated from her prior position with the college, and since then, has applied for several adjunct teaching positions across departments for which she is fully credentialed. On May 7, 2025, Petitioner submitted multiple applications and personally contacted department chairs and hiring managers via email, attaching her résumé and expressing her interest in the positions. Despite her qualifications and history with the institution, she received no responses from any department. Screenshots of the job postings and a printed copy of the email correspondence have been preserved and are attached to this petition as newly discovered evidence that supports Petitioner's claims of retaliatory conduct and systemic obstruction of future employment opportunities by the Respondent.



Petitioner firmly believes that her case has not been given fair consideration at any stage, and that her constitutional rights and protections under applicable employment and anti-retaliation laws have been disregarded. This continued and undocumented exclusion from employment within the same institution that wrongfully terminated her highlights the urgent need for this Court to rehear the matter and assess the broader implications for due process, access to justice, and accountability in public institutions.

WHEREFORE, Petitioner respectfully requests that this Honorable Court grant the petition for rehearing and allow the opportunity for her case to be fully and fairly heard.

## **AFFIDAVIT OF CONTINUED RETALIATION**



1. I am the petitioner in the case **Amia Young-Trezvant v. Lone Star College System**.



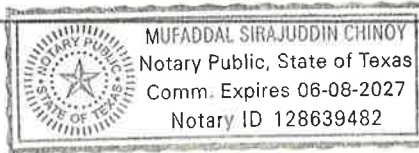
