- 1-I PETITIONER FILED A MOTION FOR LEAVE TO PROCEED IN FORMA PAUPERIS, AFFIDAVIT IN SUPPORT OF HIS MOTION AND CERTIFICATION OF PRISONER ACCOUNT STATEMENT SHOWING NO MONEY IN ACCOUNT, ALL FILED WITH PETITION.
- 2-MOTION FOR LEAVE TO PROCEED IN FORMA PAUPERIS WAS GRANTED BY THIS COURT AND UNITED STATES COURT OF APPEALS OF THE THIRD CIRCUIT. (SEE COURT ORDER GRANTING MOTION CASE NO. USAP 3 NO. 23-1617)
- 3-THIS PETITION WAS ACCEPTED BY THIS COURT AND PLACED ON THE DOCKET FEBRUARY 5, 2025 BECAUSE IT IS A NATIONAL IMPORANCE AND SHOULD BE PUBLISHED. (SEE REASONS FOR WRIT OF CERTIORARI IN PETITION.)

LEGAL ARGUMENT

I PETITIONER WANT TO DO THE RIGHT THING AND PAY THE FILING FEE BUT I CAN NOT GIVE THE COURT SOMETHING THAT I DON'T HAVE. I AM BEING BLAMED FOR ABUSE OF THIS COURT BUT THIS DOES NOT STATE HOW. I AM BEING DEPRIVED OF LAW LIBRARY GETTING PRINT OUT OFF THE COMPUTER AND MAKING COPIES BECAUSE I HAVE NO MONEY IN MY PRISON ACCOUNT. I AM 72 YEARS OLD WITH HANDICAP MEDICAL DETAILS AND I DO NOT HAVE ANYONE ON THE OUTSIDE THAT CAN HELP ME. § 1915. PROCEEDING IN FORMA PAUPERIS PART 1 (a)(4) IN NO EVENT SHALL A PRISONER



PROHIBITED FROM BRINGING A CIVIL ACTION OR APPEALING A CIVIL OR CRIMINAL JUDGEMENT FOR REASONS THAT THE PRISONER HAS NO ASSETS AND NO MEANS BY WHICH TO PAY THE INITIAL FILING FEE.

(B)(4) THE OFFICERS OF THE COURT SHALL ISSUE AND SERVE ALL PROCESS AND PERFORM ALL DUTIES IN SUCH CASES AND THE SAME REMEDIES SHALL BE AVAILABLE AS ARE PROVIDED FOR BY LAW IN OTHER CASES.
