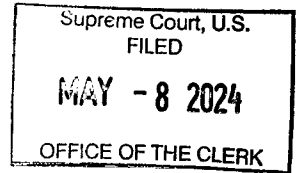

I, Abdullah Sall, petitioner, hereby declare that due to financial hardship, I will be proceeding in *forma pauperis*. I cannot afford the cost or offer security for the cost associated with filing this petition owing to the fact I still have trouble meeting my basic needs. I have not given away any valuables or property to avoid paying the court's expenses. I believe I have been transparent throughout this process, paying court fees when I have. I paid the District and Second Circuit Courts costs, demonstrating I am willing to spend my last resources to pursue justice.

I strongly believe that no matter the cost those who mistreated me and took advantage of the system should face justice. I do not have a stable employment. I work under contract, hopping from one hourly job to another. I am attaching my bank statements and previous ADP wage records to support my argument. I sincerely appreciate the Court's attention.
