

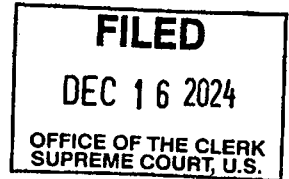


CERTIFICATE OF PRISONER ACCOUNT ACTIVITY
