

COMES NOW the petitioner, Isaac D. Koch, to pray for an order authorizing *in forma pauperis*. Leave was granted in the trial court and Iowa Supreme Court.

You want me to pay *how much* to do justice?

Whether or not the constitution levies a tax, the idea flies in the face of impartial judgment. Purchased justice is repugnant to all.

Moreover and moreover, this motion asks the Court to recognize, based on the attached documentation, that Petitioner Isaac Koch should be afforded limited *in forma pauperis* status (under federal law). Petitioner avers that *in forma pauperis* status extends more benefits than simply the ministerial act of filing the *Petition for Writ of Certiorari* (the congressionally-ratified S. Ct. Rule 39 even omits statutory authority for such status). Exhibit A is Rule 39.1's "copy of the order of appointment" (although counsel was later released from duty). Therefore, no other declaration is required. Rule 39.1. Exhibit B is the correspondence extending the timeframe for the *Petition for Writ of Certiorari*. However, because Petitioner Koch

is not a prisoner within the meaning of 28 U. S. C. § 1915, it would seem that *in forma pauperis status* is available simply because the Congress ratified court rule. Mr. Koch delimits his request for *in forma pauperis benefits* to the filing of his *Petition for Writ of Certiorari*. Remains it the ministerial act of filing the *Petition for Writ of Certiorari* for the reason of justice.

WHEREFORE, the Court should grant the *Petition for Writ of Certiorari* without a price, and afford *limited in forma pauperis status* to Petitioner Isaac Koch.

ORDER APPOINTING COUNSEL

The Court, having received and examined an application for appointment of counsel and having considered not only the applicant's income, but also the applicant's available assets and other circumstances, finds the following:

1. The Defendant:

Is eligible for court-appointed counsel pursuant to Iowa Code section 815.9 because:

the applicant's income is **at or below 125%** of the poverty guidelines and Defendant is unable to pay for the cost of an attorney; **OR**

the applicant's income is **between 125% and 200%** of the poverty guidelines and not appointing counsel would cause Defendant substantial financial hardship; **OR**

the applicant's Income is **over 200%** of the poverty guidelines, Defendant is charged with a felony, and not appointing counsel would cause Defendant substantial financial hardship.

Is not eligible for court-appointed counsel pursuant to Iowa Code section 815.9.

2. The counsel appointed below to represent the applicant is:

The local public defender office, nonprofit organization, or attorney designated by the State Public Defender pursuant to Iowa Code section 13B.4(2) to represent indigent persons in this type of case in the county **OR**

An attorney not designated by the State Public Defender, but:
Any local public defender office or other designee of the State Public Defender for this type of case in this county has been contacted and has declined the appointment or withdrawn from the case, or there is no designation for this type of case in this county, **AND** the appointed attorney:

Has a current contract with the State Public Defender to represent indigent persons in this type of case and in this county; **OR**

Does not have a contract, but all attorneys with a contract to represent indigent persons in this type of case in this county have been contacted and no such attorney is available to take this case; **OR**

Does not have such a contract, but the State Public Defender has been consulted and consents to the appointment.

IT IS THEREFORE ORDERED that the application for appointment of counsel is

Approved, and Tim Jeffrey is appointed to represent the Defendant in this case at State expense and may be contacted at 712-328-1566.
