This matter comes before the Court on the Defendant's Notice of Appeal filed on March 25, 2024. The record reflects that judgment was entered on January 24, 2024, finding the Defendant guilty as charged. Iowa Rule of Criminal Procedure 2.73(1) states, among other things, that, "A party takes an appeal by giving notice orally to the magistrate at the time judgment is rendered that the party appeals or by filings [sic] with the clerk of the district court not later than ten days after judgment is rendered a written notice of appeal.[sic]
