



Question for Review

The nature of the review is an Originalism augment as Justice Scalia's proposed this Court should review Cases. That is the basis for my request for Certiorari. The equal protection clause of the 14 amendment has been perverted into something unrecognizable to the original intent of what it was meant to do. It was meant to protect the People of the United States. But has been weaponized to oppress instead of protect.

First the Background of what got us hear. Title 6 of the Civil Rights Act was meant to protect, Protected Minorities from unequal Justice. But Title 7 was put in to make sure Regular Americans would not lose their rights under the constitution through the enforcement of title 6. That has failed causing several different levels of citizenship. Like the Cast System in India. Senator Marjory Tailor Green during then senate Hearing on Title 7 proved that fact. She also Said People don't Chose what they want to be when they are born. I have asked her to supply this Court with transcripts of her questioning and other Senators questioning of the people defending the American Cast system. That will prove my Statements are true. It is a simple fact that agencies and vendors due to the chevron doctrine have made Title 7 null and void to steal money and rights s from the American people. Title 6 does not protect, Protected Minorities. It just makes it easy for some public officials to steal the people money. That is, accomplished by putting a corrupted protected minority in a

position of authority to circumvent the constitution. After the SCOUS case Loper Bright Enterprises v. Raimondo (06/28/2024) this Court should not allow the circumventions of the constitution any more. Either everyone is protected by Title 6 or no one is. That is the only way to uphold the Equal Protection Clause of the 14 Amendment. This Court could also restore Title 7 to its original intent of protecting normal Americans. If you do Fix Title 6 and Title 7 Americans will be equal for the first time. People will stop fighting with each other. We will all be together as Americans and it will open the door to letting you Judges Administer Justice as it was meant in our Constitution.

Historical statement of what caused the present unconstitutional Cast System we are living under. JFK's administration proposed the Civil Rights act. He was assassinated. LBJ put it into law. LBJ repeatedly said it was not to give protected minorities an advantage but to promote equality. If he did not say that the American People would have opposed it. Equality was the original intent of title 6. I find it strange that Jews were not made a protected minority at that time. The reason for not including Jews was anti-Semitism. Of the Roman Catholics people who proposed it. JFK's Brain Trust who called themselves the Irish Mafia; the oppression of Jews by Title 6 worked so well. Or will this Court continue to let the American Justice System descended into something unrecognizable to the Original Intent of its drafter and the American People. Since the Third Circuit Court refused to appointment of counsel on Jan, 6, 2025, I want to add Judge Stephanos Bibas to authorities, opinions.

List of Parties and related cases, this circumvention of the constitution is going on in most Court in the United States. The worse perversion of Justice is in the Administrative Law Courts. One Example is my case to the Supreme Court January, 10,

2020; Mitchell Dinnerstein v Burlington County College, No. 19-5896. The Ruling of Judge Stephanos Bibas January, 6, 2025, and the Order of Judge Robert Kirsch.

Opinions Below, I have achieved some extraordinary things in the proses of my augments in the lower courts. I wrote a funny letter to several people in the Medea. Conan O'Brian liked it and mentored me on how to be a good writer on his podcast. I wrote another letter to President Biden and got Conan into the white house. That exposed President Biden's mental decline to the America people. I wrote another letter to Senator's John Kennedy and Marjory Tailor Green, causing Senate Hearings to be held on the, destructive Medial influence on America, DEI, Title 6, and Title 7. That exposed the attack being perpetrated on America by enemies both foreign and Domestic. I wrote a Letter to, Elon Musk, Bill Gates, and Mark Zuckerberg. Asking them to change their business models to help America and get involved to stop the attack on America. I think all three of them did what I asked. I want to thank them. That letter caused them to move up a Presidential Debate, which led to President Biden being forced out of the Presidential Race.

During the Debate President Trump Kept Saying Wait and Just let him get elected. I was also worried about the Districted Court Judge Robert Kirsch who let me write all of those letters. If he ruled for me, the enemies of America both foreign and domestic would have destroyed him. NJ is run by Organized Crime. The Justice complex in NJ is named after an associate of the Decavalcante crime family; the TV show the Sopranos is based on. If this Court does not fix the inequality Title 6's false interpretation is causing in the Justice system. We will , have a Holocaust in the future. It also can be fixed by a Presidential Executive Order on Title 6 making all Americans

Equal. Or Congress Addressing it and passing laws to correct the Injustice.

Jurisdiction, this is going on in every courtroom in America this court has Jurisdiction. Date of Judgment is November, 15, 2024. Circuit Judge Stephanos Bibas, for not appointing me Council.

Constitutional and Statutory Provision, The unconstitutionality of Title 6's false interpretation is in direct opposition of the Equal Protection clause of the 14 Amendment; which can now be addressed because of the case, SCOTUS 22-451 Loper Bright Enterprises v. Remondo. Title 7 can also be restored to its original intent to protecting regular Americans from overreach in the enforcement of title 6.

Statement of the case, Title 6 has destroyed my life. I have gone to therapy because of it. I have wrongfully lost every Government job and most private sectors Job's I have ever had because of it. I have lost my Pension because of it. I was denied Social Security because of it; I was denied Unemployment Insurance Because of it. I have been constantly slandered devalued and harried because of it. I have been charged with crimes I did not comet because of it. I have lost Government Grants because of it. I have been shaken down by Government Officials because of it. It has driven me to disperse. Making me not wanting to live, under the evil false interpretation of title 6

making title 7 null and void; the people perpetrating that false interpretation of Title 6 are not doing it for Civil Rights. It is just to take the peoples, Federal and States money and goods. Then the corrupt Politicians and their shills keep the money and goods for themselves. They take all the good things in life they can and keep them for themselves. That form of Governing is a parasitic relationship. Woke shills, and crooked Politicians take everything from the American people, protected minorities and non-protected minorities alike. And the end goal is to take everything until there is nothing left. The goal is to make America look like LA California after the fires, caused by the incompetence of the four Roman Catholic Lesbian heads of the LA fire Department. I also am a Protected Minority who has not been recognized as such all my life. So even under the evil false interpretation of title 6, I was always supposed to be represented. I will enclose a copy of my DNA marked (A). I am 66.9% Jewish that really means I am 66.9% Arab. If you get a Scientist with a PHD in Genetics he will confirm a Mizahi Jew like me are Arab. I am requesting President Trump instructs the Justice Department appoint a lawyer to represent me for the reasons I have stated above and please send a letter to the Court in support of my Petition from Certiorari.
