

STATEMENT OF JURISDICTION

**The United States Supreme Court has Jurisdiction to Review the Opinion of the
Eleventh Circuit Court Of Appeals entered on September 5, 2024 , Case No. 23-12543.**

STATEMENT OF CASE

The Eleventh Circuit Court Of Appeals found that Georgia Court Clerks are not subject to lawsuits under Section 42, 1983 Civil Rights Act. ACCORDING UNDER GEORGIA LAW ANY GEORGIA CLERK CAN DENY TO FILE A LEGAL MOTION TO SET ASIDE — **WITHOUT — A COURT ORDER.** Therefore Georgia Law — **OVERRIDES** — FEDERAL LAW. Petitioner claims Georgia law cannot override federal law. **OTHERWISE, A GEORGIA CLERK IS SOVEREIGN GATEKEEPER TO GEORGIA COURTS.**

REASON FOR GRANTING WRIT

The Court ruled that Georgia law can grant “**ABSOLUTE IMMUNITY**” (i,e A judges immunity) to any party. **ACCORDINGLY, Georgia law OVERRIDES Federal law.**

The Appeals Court wrongly found that Clerk Robinson “**MISINTERPRETED**” a court order. **BUT, THERE WAS – NO ORDER – TO “MISINTERPRET.”**

CONCLUSION

The petition for a writ of certiorari should be granted.
