PETITIONER'S PETITION FOR REHEARING

Petitioner sought certiorari to review whether his firearms-related conviction violated the Second Amendment. This Court denied certiorari on June 2, 2025, making this petition for rehearing due 25 days later, or by June 27, 2025. *See* Sup. Ct. R. 44.2.

Petitioner Brito's certiorari petition listed several other certiorari petitions filed in this Court also seeking review of whether firearms-related convictions violated the Second Amendment. Three of those petitions were distributed at the June 26, 2025 conference: (1) *United States v. Collette* (Sup. Ct. No. 24-6497), (2) *United States v.* *Curry* (Sup. Ct. No. 24-7290), and (3) *United States v. Thompson* (Sup. Ct. No. 24-6693). The orders granting or denying certiorari on these three cases will not be issued until after this rehearing petition is due on June 27, 2025, so petitioner Valente Brito, Jr., is filing this rehearing petition to preserve the option of rehearing being granted in this case if this Court grants certiorari in any of the three petitions to be discussed at the June 26, 2025 conference.

If review is granted and a decision reached in any of those three cases, then this Court should grant this petition for rehearing, then grant, vacate and remand this case for further proceedings consistent with the opinion issued in the case that is granted certiorari.

The Certificate of Counsel required by Sup. Ct. R. 44, stating that this rehearing petition is brought in good faith, and not for delay, is attached to the end of the printed copies of this rehearing petition, and electronically filed as a separate document.

Conclusion and Prayer for Relief

WHEREFORE, PREMISES CONSIDERED, petitioner VALENTE BRITO, JR. respectfully prays that if certiorari is granted in any of the three certiorari petitions named herein to be discussed at the June 26, 2025 conference, that this Court should then grant this petition for rehearing, and then grant, vacate and remand this case for further proceedings consistent with the opinion issued in the case that is granted certiorari.
