**MOTION FOR LEAVE TO PROCEED *IN FORMA PAUPERIS***

---

Pursuant to Rule 39 of the Rules of the Supreme Court, Malik Moss requests leave to file the attached Petition for Writ of Certiorari without prepayment of costs and further requests to proceed *in forma pauperis*. Mr. Moss has been found to be indigent and was appointed Counsel pursuant to the Criminal Justice Act by the United States Circuit Court of Appeals for the Third Circuit as well as the United States District Court for the District of Delaware. Throughout Mr. Moss' proceedings in the Delaware District Court and the United States Court of Appeals for the Third Circuit he has not been required to pay any filing fees or costs due to the Delaware District Court's finding of indigence. Mr. Moss continues to be indigent and unable to earn monies to provide for private counsel or to pay filing fees or costs due to his current sentence of incarceration.

Attached as Exhibit A to this Motion for Leave to Proceed *in Forma Pauperis* is a copy of

the United States Circuit Court of Appeals for the Third Circuit's order appointing Mr. Moss counsel under the Criminal Justice Act on November 17, 2023. Attached as Exhibit B to this Motion is a partial copy of the United States District Court for the District of Delaware's docket report showing an oral order appointing Mr. Moss Counsel under the Criminal Justice Act on December 14, 2021.

WHEREFORE, it is requested that the Motion for Leave to Proceed *In Forma Pauperis* be GRANTED.
