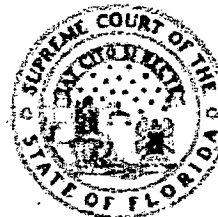

**BY ORDER OF THE COURT:**

By order entered July 25, 2024, Petitioner was ordered to show cause why sanctions should not be imposed for Petitioner's history of filing repetitious frivolous petitions and appeals, including the petition in this case. This court found that Petitioner's pro se filings in this court constitute an abuse of this court's processes. \* *See Hamilton v. State*, 945 So. 2d 1121 (Fla. 2006); *Jackson v. Fla. Dep't of Corrs.*, 790 So. 2d 398 (Fla. 2001). Petitioner did not respond to the order to show cause.

Because Petitioner's repetitious, frivolous filings have become an abuse of the legal process, we hold that Petitioner is barred from future pro se filings in this court. The Clerk of the Court is directed not to accept any future filings by Tristan Michael Hyde, DC# 171916, unless they are filed by a member in good standing of The Florida Bar. This includes any post-disposition motion filed in response to this order.

Petitioner is warned that any filings that violate the terms of this order may result in a referral to the appropriate institution for disciplinary procedures as provided in section 944.279, Florida Statutes. See Fla. R. App. P. 9.410.

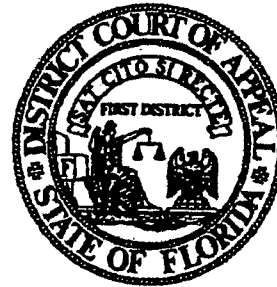

Good Afternoon,

On July 24, 2024, at approximately 1415, I received a FedEx package containing a flash drive, a copy of the court orders, and a letter from Mr. Pike addressed to Capt. McCormick. The letter outlined the court order and included a notice of filing exhibits conventionally.

On July 25, 2024, at approximately 0800, I began reviewing the documents on the flash drive to ensure the video content did not jeopardize the safety and security of the facility. While reviewing the files, we received an order from the Florida Department of Corrections to release their current hold, resulting in Inmate Hyde no longer having any open charges within our county. Inmate Hyde has a hold for Santa Rosa County and will be transported there today July 25, 2024. Due to this transfer, Inmate Hyde has not been afforded the opportunity to review the files on the flash drive. Based on the court order, the flash drive need not be given to plaintiff Inmate Hyde to retain due to potential security concerns.

Contact will need to be made with Santa Rosa County to inform them of the court order for Inmate Hyde to review the files on or before August 9, 2024, as outlined in the order. A new flash drive will need to be mailed to Santa Rosa County. The flash drive containing the files will be disposed of at the Walton County Jail.
