COMES NOW, Percy L. Harris, petitioner, pro se, pursuant to Rules 33.2 and 39, files this Motion for Leave to Proceed In Forma Pauperis. The support thereof would show the following:

STATEMENT

On October 17, 2022, Harris' jury trial commenced. On October 20, 2022, the jury returned a guilty verdict, and the court sentenced Harris to life imprisonment.

On November 17, 2022 Harris' trial attorney filed a Motion to Withdraw and for Appointment of Appellate Counsel and for Authority to proceed on appeal In Forma Pauperis. The Motion was granted by the trial court and the order was filed on November 18, 2022 and is attached to the petition as Appendix C.


Harris' appeal proceeded and was affirmed by the Mississippi Supreme Court on February 29, 2024. Harris has remained incarcerated in the custody of the Mississippi Department of Corrections throughout this process and is continuously attempting to perfect appeal.

Due to being incarcerated since December 23, 2019, the petitioner is unable to pay the cost of appeal and is requesting this motion is granted and this Honorable Court allow me to proceed without prepayment of costs and declare that I am unable to pay the fees and are entitled to proceed as a pauper. If granted, the petitioner will be able to proceed with the pending Petition for Writ of Certiorari that is requesting this court to review the decision of the Mississippi Supreme Court, in which filed documents went omitted and were not made a part of the record.

WHEREFORE, PREMISES CONSIDERED, Petitioner Percy L. Harris respectfully requests this honorable Court to grant him leave to proceed In Forma Pauperis. If granted, the petitioner will be able to proceed with his Petition for Writ of Certiorari in this court.


