PETITIONER'S CORRECTED
APPLICATION FOR LEAVE TO PROCEED IN
FORMA PAUPERIS

COMES NOW petitioner, Jeffrey Weinhaus, by and through counsel, and submits to this Court, pursuant to Rule 39, his application for leave to proceed in forma pauperis on his Petition for Writ of Certiorari to the Missouri Supreme Court. In support of this application, petitioner states as follows:

1. Mr. Weinhaus' Petition for Writ of Certiorari seeks review of the judgment of the Missouri Supreme Court in *Weinhaus v. Adams*, No. SC100827 (Filed Dec. 23, 2024), affirming dismissing his Petition for Writ of Habeas Corpus filed pursuant to Missouri Rule 91 challenging the constitutionality of his

convictions of Assault and Armed Criminal Action and sentence of thirty years.

Mr. Weinhaus has been continuously incarcerated since 2012 and is a poor person without means to pay fees or expenses related to his petition.

2. Mr. Weinhaus was represented by retained counsel at his trial in the Circuit Court of Franklin County, Missouri. However, after Mr. Weinhaus was convicted, the Honorable Keith Sutherland of the Franklin County Circuit Court granted Mr. Weinhaus leave to appear in forma pauperis. See Exhibit A, *State v. Weinhaus*, Franklin County No. 12AB-CR02409-01, Docket Entry of December 5, 2013, stating, “Defendant granted leave to appeal in forma pauperis.” Judge Sutherland also appointed the public defender to represent Mr. Weinhaus. See Exhibit B, *State v. Weinhaus*, Franklin County No. 12AB-CR02409-01, Docket Entry of December 10, 2013, stating, “Motion for Appointment of Counsel is granted. Public Defender appointed. Defendant Weinhaus to complete an Application for Public Defender Services if he has not already done so.”

3. The public defender continued to represent Mr. Weinhaus in his State postconviction motion pursuant to Missouri Rule 29.15 and on appeal therefrom, Mr. Weinhaus was again granted leave to proceed as a poor person. See Exhibit C, *Weinhaus v. State*, No. 15AB-CC00117, Order of December 28,

2015, ordering that “Movant may proceed in forma pauperis.”

4. Mr. Weinhaus’ public defender, Ms. Amy Bartholow, moved to grant Mr. Weinhaus leave to proceed in forma pauperis on his petition for writ of habeas corpus in the Circuit Court of St. Francois County. The Honorable Troy Hyde granted that motion, stamping and signing his ruling on the last page of that motion, attached as Exhibit D., *Weinhaus v. Payne*, St. Francois County No. 20SF-CC00053, p. 4 (Order dated April 21, 2020).


5. Following the summary denial of his petition for writ of habeas corpus in the St. Francois County Circuit Court, Mr. Weinhaus sought leave to proceed in forma pauperis in habeas corpus proceedings in the Missouri Court of Appeals, Eastern District, which was granted. Exhibit E, *Weinhaus v. Payne*, Eastern District Court of Appeals No. ED109329, Order, December 9, 2020.

6. Due to personal circumstances, Ms. Bartholow was not able to continue her representation of Mr. Weinhaus, and recruited the undersigned counsel, who agreed to represent Mr. Weinhaus pro bono, without payment of fees or expenses. Simply for expedience, undersigned counsel paid the filing fee in the Missouri Supreme Court and did not seek appointment or leave to proceed in forma pauperis in that court even though Mr. Weinhaus remains a poor person without means to hire counsel or pay expenses.

7. Mr. Weinhaus' Affidavit or Declaration in Support of Motion for Leave to Proceed In Forma Pauperis, accompanied by a notarized Missouri Department of Corrections Offender Financial Services Account Statement, is submitted as Exhibit F.

WHEREFORE, Petitioner Jeffrey Weinhaus respectfully requests that this Court grant him leave to proceed *in forma pauperis* on his petition for a writ of certiorari, and to enter such further order as the Court deems just and appropriate.



MOTION TO RECONSIDER AND FILE PETITION PURSUANT TO
PENDING *IN FORMA PAUPERIS* MOTION AS THE PLRA DOES NOT
APPLY TO PETITIONER'S HABEAS CASE, AS DETERMINED BY STATE
V. MCELWAIN, 140 S.W.3D 36 (MO BANC 2004), AND HIS INDIGENT
STATUS HAS BEEN DETERMINED BY THE PUBLIC DEFENDER

Comes now Amy M. Bartholow, Assistant Public Defender and attorney for the Petitioner, Jeffrey Weinhaus, and moves this Honorable Court to allow Petitioner to file his Petition for Writ of Habeas Corpus as a poor person pursuant to the current *In Forma Pauperis* motion filed contemporaneously with his Petition. In support, Petitioner states:

1. On April 8, 2020, Petitioner filed in this Court a Petition for Writ of Habeas Corpus, Writ Summary, Appendix, and a Motion to file these documents *In Forma Pauperis*;
2. Petitioner's *In Forma Pauperis* Motion recounted that Petitioner is without funds to pay the costs of this cause, that he has been accepted as

indigent by the Office of State Public Defender pursuant to Chapter 600, RSMo., that he is represented by an assistant public defender in this case and he is confined in the Eastern Reception Diagnostic and Correctional Center on a thirty year aggregate sentence;

2. On April 14, 2020, the Honorable Judge Hyde was assigned to Petitioner's case;

3. On April 15, 2020, by docket entry, Judge Hyde ordered: "Pursuant to the Prison Litigation Reform Act" [PLRA] Petitioner shall file a copy of his Inmate Prison Account Statement within 30 days or "otherwise [t]he Court will dismiss his application summarily;"

4. However, the PLRA does not give this Court jurisdiction or discretion to assess costs or fees against Petitioner in this case. See *State ex rel. Francis v. McElwain*, 140 S.W.3d 36 (Mo. banc 2004); *Versey v. Jirak*, 219 S.W.3d 774 (Mo. App. E.D. 2007); *Kocina v. Johannes*, 505 S.W.3d 474 (Mo. App. W.D. 2016). Rather, in *McElwain*, the Missouri Supreme Court determined that Section 514.040.3, RSMo., trumps the PLRA, Section 506.369, where the Petitioner is represented by the Office of State Public Defender in a state habeas action. *McElwain*, 140 S.W.3d at 38.

5. In *McElwain*, Petitioner Francis, like Petitioner Weinhaus, had attempted to file a petition for a writ of habeas corpus, *in forma pauperis*, to challenge his convictions and sentences, but the trial court, relying on the

provisions of the PLRA, refuse to allow the filing of the petition without payment of a partial filing fee and monthly payments thereafter until the fee was paid in full. The Missouri Supreme Court rejected such attempt and ordered the trial court to file the petition.

6. The Court held that, under Section 514.040.3, all costs and expenses related to the prosecution of such habeas action may be waived without the necessity of a motion and court approval, provided that a determination has been made by the Office of State Public Defender that the Petitioner is unable to pay the costs, fees and expenses necessary to prosecute the action and such has been certified and filed with the clerk of the court;

7. Here, the OSPD has determined Petitioner Weinhaus to be indigent and has accepted representation in this case, as allowed pursuant to its discretion, to challenge the validity of the judgment and sentences in his underlying criminal case. See *Id.* at 38-39. It is allowed to do so as “an independent department of the judicial branch of state government.” *Id.* at 38 (citing Section 600.019.1 RSMo). He is currently represented in this action by Assistant Public Defender Amy M. Bartholow;

8. Therefore, Petitioner requests that this Court rescind its prior order and direct the Clerk to accept his Petition for Writ of Habeas Corpus without further determination of his ability to pay costs and expenses of this action.


