I represent the respondent in the above-entitled case. The petition for a writ of habeas corpus was filed on May 27, 2025, was docketed on June 17, and was distributed the next day for the September 29 conference. Although not noted on the petition's Questions Presented page, this is in fact a capital case. As a result, a response is currently due on July 17. Pursuant to Rule 30.4, I respectfully request that the time for filing that brief be extended by thirty days, to August 16, 2025.

This is respondent's first request for an extension of time. My office was not served with the petition for writ of habeas corpus at the time it was filed, and I first learned of the petition on July 9, 2025.
