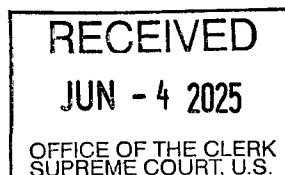
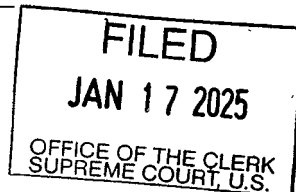
The petitioner asks for leave to file the attached petition for a writ of certiorari without prepayment costs and to proceed *in forma pauperis*.






