MOTION FOR LEAVE TO PROCEED IN FORMA PAUPERIS



AFFIDAVIT OR DECLARATION

IN SUPPORT OF MOTION FOR LEAVE TO PROCEED IN FORMA PAUPERIS

I, Jacob Mathias Rubinstein, am the petitioner in the above-entitled case. In support of my motion to proceed in forma pauperis, I state that because of my poverty I am unable to pay the costs of this case or to give security therefor; and I believe I am entitled to redress. As an inmate confined to an institution, I have very limited financial resources. I have no spouse, receive minimal financial support from family, and my income from prison employment is very low. The following comprises my entire financial position:



I do not expect any major changes to my monthly income or expenses or in my assets or liabilities during the next 12 months.

I have not and will not be paying an attorney or any other person for services in connection with this case.

My employment income recently declined due to my enrollment in the Residential Drug Abuse Program (RDAP), reducing my working hours. My restitution is paid through the prison financial responsibility program by deducting 50% of my employment pay. Gifts from family are provided so I can purchase commissary items. My pre-release account is meant to provide funds upon my release. I have no other outside assets or liabilities, no dependents, no sources of income, no outstanding debts or monies owed to me.
