## Order Dismissing Appeal

This Court entered an Order Conditionally Dismissing Appeal on March 10, 2025, as the required fee for preparation of the Clerk's Record, pursuant to I.A.R. 27(c), had not been paid to the District Court Clerk nor had an Order been obtained from the District Court waiving that required fee or, appointing the State Appellate Public Defender. The appeal was suspended for twenty-one (21) days for Appellant to pay the required fee for preparation of the Clerk's Record to the District Court Clerk or, obtain an order from the District Court either waiving that required fee for preparation of the Clerk's Record or, appointing the State Appellate Public Defender.

1. A letter in Response to ORDER CONDITIONALLY DISMISSING APPEAL and NOTICE TO TAKE JUDICIAL NOTICE THAT THE IDAHO SUPREME COURT REPRESENTATIVE HAS AGREED WITH IDAHO LEGISLATURE AND BOTH PARTIES THAT A "LIFE SENTENCE IN IDAHO IS 30 YEARS" were filed by Appellant on March 19, 2025.
2. An Order Denying Waiver of Fee for Preparation of the Clerk's Record was filed in the District Court on March 20, 2025,
3. A PETITION BY PRO SE DEFENDANT FOR WAIVER OF FEES FOR PREPARATION OF COURT'S RECORD and PETITION FOR AN ORDER TO HAVE PRISON OFFICIALS RETURN PROPERTY AND FILES STOLEN 04 MARCH 2025, AS RETALIATION were filed by Appellant on March 24, 2025.
4. A PETITION FOR LAWFULL [sic] LEGAL ACCESS TO SEEK REDRESS was filed by Appellant on March 26, 2025.
5. A PETITION TO ORDER IDAHO DEPARTMENT OF CORRECTIONS TO RETURN ALL DOCUMENTS AND PAPERWORK TAKEN SINCE THE 1981 TRIAL, SUPPLEMENTAL REQUEST TO DOCUMENTS ON NOTICE OF APPEAL, PETITION TO ORDER IDOC JUDICIAL AUTHORITIES REBECCA STRAUSS AND SHERYL LA FLAMME TO RECOGNIZE: 1. ALL PAST CASES AS "ACTIVE" FOR APPEALS 2. TO ALLOW

DEFENDANT TO SEEK ALL PAST CASE RELATED DOCUMENTS FROM ALL SOURCES AT STATE/IDOC EXPENSE, and PETITION TO: 1. ORDER IDOC TO ALLOW LACEY TO HAVE HIS CASE FILES AT HIS CELL 2. PREVENT IDOC STAFF OR AGENTS FROM STEALING LACEY'S FILES 3. REQUIRE IDOC TO HAVE LACEY VISUALLY PRESENT WHEN SEARCHING FILES/MATERIALS 4. ORDER IDOC AND ITS CONTRACTOR TO ALLOW LACEY ALL ACCESS TO HIS FILES WHEN CONTRACTOR IS CHANGED were filed by Appellant on March 31, 2025.

6. A SUPPLEMENT TO "PETITION FOR AN ORDER TO HAVE PRISON OFFICIALS RETURN PROPERTY AND FILES STOLEN 04 MARCH 2025" AND LIST OF PROPERTY AND FILES, NOTICE FOR JONAH HORWITZ TO CONTINUE TO BE AMICUS CURIAE ON APPEAL, and RESUBMITTED NOTICE TO TAKE JUDICIAL NOTICE THAT THE IDAHO SUPREME COURT REPRESENTATIVE HAS AGREED WITH THE IDAHO LEGISLATURE AND BOTH PARTIES THAT A "LIFE SENTENCE IN IDAHO IS 30 YEARS" were filed by Appellant on April 7, 2025.

Therefore, after due consideration,

IT IS ORDERED that Appellant's NOTICE TO TAKE JUDICIAL NOTICE THAT THE IDAHO SUPREME COURT REPRESENTATIVE HAS AGREED WITH IDAHO LEGISLATURE AND BOTH PARTIES THAT A "LIFE SENTENCE IN IDAHO IS 30 YEARS" is DENIED.

IT IS FURTHER ORDERED that Appellant's PETITION FOR AN ORDER TO HAVE PRISON OFFICIALS RETURN PROPERTY AND FILES STOLEN 04 MARCH 2025, AS RETALIATION is DENIED.

IT IS FURTHER ORDERED that Appellant's PETITION FOR LAWFULL [sic] LEGAL ACCESS TO SEEK REDRESS is DENIED.

IT IS FURTHER ORDERED that Appellant's PETITION TO ORDER IDAHO DEPARTMENT OF CORRECTIONS TO RETURN ALL DOCUMENTS AND PAPERWORK TAKEN SINCE THE 1981 TRIAL, SUPPLEMENTAL REQUEST TO DOCUMENTS ON NOTICE OF APPEAL, PETITION TO ORDER IDOC JUDICIAL AUTHORITIES REBECCA STRAUSS AND SHERYL LA FLAMME TO RECOGNIZE: 1. ALL PAST CASES AS "ACTIVE" FOR APPEALS 2. TO ALLOW DEFENDANT TO SEEK ALL PAST CASE RELATED DOCUMENTS FROM ALL SOURCES AT STATE/IDOC EXPENSE, and PETITION TO: 1. ORDER IDOC TO ALLOW LACEY TO HAVE HIS CASE FILES AT HIS CELL 2. PREVENT IDOC STAFF OR AGENTS FROM STEALING LACEY'S FILES 3. REQUIRE IDOC TO HAVE LACEY VISUALLY PRESENT WHEN SEARCHING FILES/MATERIALS 4. ORDER IDOC AND ITS CONTRACTOR TO ALLOW LACEY ALL ACCESS TO HIS FILES WHEN CONTRACTOR IS CHANGED are DENIED.

IT IS FURTHER ORDERED that Appellant's SUPPLEMENT TO "PETITION FOR AN ORDER TO HAVE PRISON OFFICIALS RETURN PROPERTY AND FILES

STOLEN 04 MARCH 2025" AND LIST OF PROPERTY AND FILES, NOTICE FOR JONAH HORWITZ TO CONTINUE TO BE AMICUS CURIAE ON APPEAL, and RESUBMITTED NOTICE TO TAKE JUDICIAL NOTICE THAT THE IDAHO SUPREME COURT REPRESENTATIVE HAS AGREED WITH THE IDAHO LEGISLATURE AND BOTH PARTIES THAT A "LIFE SENTENCE IN IDAHO IS 30 YEARS" are DENIED.

IT IS FURTHER ORDERED that Appellant's PETITION BY PRO SE DEFENDANT FOR WAIVER OF FEES FOR PREPARATION OF COURT'S RECORD is DENIED and the above-entitled appeal is DISMISSED.


