I, Carrie Goldberg, a member of the Bar of this Court and counsel of record for Petitioner, John Doe, hereby certify, pursuant to Rule 29.2, that on May 5, 2025, I timely filed Petitioner's Application for an Extension of Time to file Petition for a Writ of Certiorari ("Application"), and proof of service through the Court's electronic filing system.

If my Application is not Granted, my Petition for a Writ will be due on May 19, 2025.

This is my first time filing as lead counsel to the Supreme Court of the United States.

On May 5, 2025, I electronically filed this Application onto the Supreme Court Electronic Filing System and I personally mailed a copy of this Application to the Supreme Court by affixing a 1<sup>st</sup> Class stamp onto the envelope properly addressed to the Clerk of this Court in accordance with Supreme Court Rule 22.2 and 29.3 and placing it in a USPS blue mailbox outside my office at 16 Court Street, 33<sup>rd</sup> Floor. I also emailed the Application to opposing counsel.

On May 6, 2025, I realized the signature date was incorrect on the May 5<sup>th</sup> Application. Fixing the date, I filed a Corrected Application for an Extension of Time to file Petition for Writ of Certiorari ("Corrected Application") on the Supreme Court Electronic Filing System. My Associate, Zaynah Chaudhury, personally mailed a copy of this Corrected Application Supreme Court by affixing a 1<sup>st</sup> Class stamp onto the envelope

properly addressed to the Clerk of this Court in accordance with Supreme Court Rule 22.2 and 29.3 and placing it in a USPS blue mailbox outside my office at 16 Court Street, 33<sup>rd</sup> Floor. I also emailed the Corrected Application to opposing counsel and I sent it to opposing counsel by USPS, using the same blue USPS mailbox.

Concerned about the passage of time, on May 12, 2025, I contacted the Clerk at The Supreme Court to confirm receipt of the Application/Corrected Application. They had not yet received the mailed copies. The Clerk recommended I follow up on May 14, 2025 if I had not received a response to the Application/Corrected Application.

Today, on May 14, 2025, I spoke to Angela Jiminez at the Clerk's Office who recommended that I file the instant Declaration affirming compliance with Rule 29.2 and provided the contact information for Sara Simmons, Case Analyst.

Today, my paralegal, Bibiane Marc, contacted Sara Simmons, Case Analyst, who advised to resubmit the filing today with appendices including the lower court decisions.

Today, I contacted Opposing Counsel. They confirmed that they had received both the mailed and emailed copies of the Application/Corrected Application. They received the Corrected Application on May 13, 2025.

Accordingly, I request that the Supreme Court accept the Application/Corrected Application as timely filed pursuant to Rule 13.1

and 29.2. I declare under penalty of perjury that the foregoing is true and correct.


