For extraordinary circumstances (beyond Petitioner's control) briefly discussed herein, Petitioner respectfully requests, in accordance with Rule 13.5, an extension to file his Petitions for Writ of Certiorari.

Petitioner's seeking review by this Court ("SCOTUS") of the R.I. Supreme Court's ("RISC") 1/30/25 dismissal orders (Appendix A & B). Per Rule 13.1, Petitioner's deadline to appeal to SCOTUS is 6/5/25 (RISC denied rehearings on 3/7/25 (Appendix C & D)). SCOTUS has jurisdiction under 28 U.S.C. §1257.
