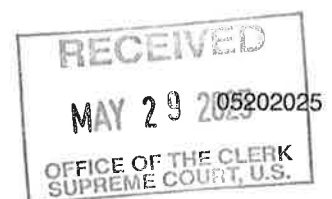
Motion for Extension Time of Writ of Certiorari

This is Xiao Qing Liu. I Motion for Extension Time of Writ of Certiorari.

The extension time is important for this case because the Court has hidden defendants in suit of docket sheet. The Eastern District of New York (EDNY) Judge used Firefox Browser to contact opponent parties of lawyers, did *Ex-Parte* trial in case, using opponent parties perjury and falsely statement. I has serviced by Hand delivery on 04/23/2025. However, Court sent a file late order to denied, dated 05/01/2025 [entered: 04:38 PM]; (Attach 6).
